AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, providing for the United States Olympic plates.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Title 75 of the Pennsylvania Consolidated
- 6 Statutes is amended by adding a section to read:
- 7 § 1370. United States Olympic plates.
- 8 (a) General rule. -- The department, in consultation with the
- 9 United States Olympic Committee or its designees, shall design a
- 10 special United States Olympic registration plate which shall
- 11 <u>display the official United States Olympic Committee logo and</u>
- 12 wording which indicates support for the advancement of
- 13 <u>excellence in amateur athletic competition in this Commonwealth.</u>
- 14 Upon application of any person, accompanied by an additional fee
- 15 of \$40, which shall be in addition to the annual registration
- 16 fee, the department shall issue the plate for a passenger car,

- 1 motor home, trailer or truck with a registered gross weight of
- 2 not more than 10,000 pounds.
- 3 (b) Initial fee. -- Of the initial fee charged for the United
- 4 States Olympic Registration Plate, \$20 shall be retained by the
- 5 Commonwealth and \$20 shall be distributed to the United States
- 6 Olympic Committee, which may distribute the funds to one or more
- 7 organizations in this Commonwealth which focus on the
- 8 <u>advancement of excellence in amateur athletics.</u>
- 9 (c) Renewal fee. -- An annual fee of \$25 shall be charged, in
- 10 addition to the annual registration fee, for the United States
- 11 Olympic Registration Plate. Of the renewal fee, the United
- 12 States Olympic Committee shall distribute at least 50% to one or
- 13 more organizations in this Commonwealth which focus on the
- 14 advancement of excellence in amateur athletics as designated by
- 15 the United States Olympic Committee.
- 16 Section 2. This act shall take effect in 60 days.
