AN ACT

1 Amending the act of November 24, 1998 (P.L.882, No.111),
2 entitled "An act providing for victims' rights; imposing
3 penalties; establishing remedies; establishing the Office of
4 Victim Advocate, the Bureau of Victims' Services, the
5 Victims' Services Advisory Committee, the State Offender
6 Supervision Fund and other funds; and making repeals," in
7 preliminary provisions, further providing for definitions; in
8 crime victims, further providing for rights, for
9 responsibilities of victims of crime under basic bill of
10 rights, for responsibilities of State and local law
11 enforcement agencies and for responsibilities of prosecutor's
12 office; in administration, further providing for office, for
13 powers and duties of victim advocate and for powers and
14 duties of Office of Victims' Services; in compensation,
15 further providing for persons eligible for compensation, for
16 filing of claims for compensation, for minimum allowable
17 claim, for determination of claims, for emergency awards, for
18 awards and for confidentiality of records; in services,
19 further providing for eligibility of victims; in financial
20 matters, further providing for costs and for costs for
21 offender supervision programs; and, in enforcement, further
22 providing for subrogation.

23 The General Assembly of the Commonwealth of Pennsylvania
24 hereby enacts as follows:

25 Section 1. The definitions of "crime," "family,"
26 "intervenor," "local law enforcement agency," "loss of
27 earnings," "out-of-pocket loss" and "personal injury crime" in

1 section 103 of the act of November 24, 1998 (P.L.882, No.111),
2 known as the Crime Victims Act, are amended and the section is
3 amended by adding definitions to read:

4 Section 103. Definitions.

5 The following words and phrases when used in this act shall
6 have the meanings given to them in this section unless the
7 context clearly indicates otherwise:

8 * * *

9 "Campus police." As defined in section 302 of the act of
10 November 29, 2004 (P.L.1383, No.180), known as the Uniform Crime
11 Reporting Act.

12 * * *

13 "Crime." An act which was committed:

14 (1) In this Commonwealth by a person, including a
15 juvenile, without regard to legal exemption or defense which
16 would constitute a crime under the following:

17 (i) The act of April 14, 1972 (P.L.233, No.64),
18 known as The Controlled Substance, Drug, Device and
19 Cosmetic Act.

20 (ii)
21 18 Pa.C.S. (relating to crimes and offenses).
22 30 Pa.C.S. § 5502 (relating to operating
23 watercraft under influence of alcohol or controlled
24 substance).

25 30 Pa.C.S. § 5502.1 (relating to homicide by
26 watercraft while operating under influence).

27 The former 75 Pa.C.S. § 3731 (relating to driving
28 under influence of alcohol or controlled substance).

29 75 Pa.C.S. § 3732 (relating to homicide by
30 vehicle).

1 75 Pa.C.S. § 3732.1 (relating to aggravated
2 assault by vehicle).

3 75 Pa.C.S. § 3733 (relating to fleeing or
4 attempting to elude police officer).

5 75 Pa.C.S. § 3734 (relating to driving without
6 lights to avoid identification or arrest).

7 75 Pa.C.S. § 3735 (relating to homicide by
8 vehicle while driving under influence).

9 75 Pa.C.S. § 3735.1 (relating to aggravated
10 assault by vehicle while driving under the
11 influence).

12 75 Pa.C.S. § 3742 (relating to accidents
13 involving death or personal injury).

14 75 Pa.C.S. § 3742.1 (relating to accidents
15 involving death or personal injury while not properly
16 licensed) if the nature and circumstances of the
17 offense committed are substantially similar to an
18 offense under 75 Pa.C.S. § 3742.

19 75 Pa.C.S. Ch. 38 (relating to driving after
20 imbibing alcohol or utilizing drugs).

21 (iii) The laws of the United States.

22 (2) Against a resident of this Commonwealth which would
23 be a crime under paragraph (1) but for its occurrence in a
24 location other than this Commonwealth.

25 (3) Against a resident of this Commonwealth which is an
26 act of international terrorism.

27 * * *

28 "Family." When used in reference to an individual:

29 (1) anyone related to that individual within the third
30 degree of consanguinity or affinity;

1 (2) anyone maintaining a common-law relationship prior
2 to January 2, 2005, with that individual; or

3 (3) anyone residing in the same household with that
4 individual.

5 "Financial support." Includes the loss of court-ordered
6 child or spousal support payments if the victim is deprived of
7 money as a direct result of a crime.

8 * * *

9 "Intervenor." An individual who goes to the aid of another
10 and suffers physical or mental injury or death as a direct
11 result of acting not recklessly to prevent the commission of a
12 crime, to lawfully apprehend a person reasonably suspected of
13 having committed such crime or to aid the victim of such crime.
14 The term does not include an enforcement officer or investigator
15 injured in the performance of his or her duties, eligible for
16 benefits under the act of June 28, 1935 (P.L.477, No.193),
17 referred to as the Enforcement Officer Disability Benefits Law,
18 or under the act of June 2, 1915 (P.L.736, No.338), known as the
19 Workers' Compensation Act.

20 * * *

21 "Local law enforcement agency." A police department of a
22 city, borough, incorporated town or township or campus police.

23 "Loss of earnings." [**Includes**] An economic loss resulting
24 from an injury or death to a victim of a crime that has not been
25 and will not be reimbursed from any other source. The term
26 includes the loss of the cash equivalent of one month's worth of
27 Social Security, railroad retirement, pension plan, retirement
28 plan, disability, veteran's retirement, [**court-ordered child**
29 **support or court-ordered spousal**] loss of support payments if
30 the payments are the primary source of the victim's income or

1 other similar benefit, and the victim is deprived of money as a
2 direct result of a crime.

3 "Loss of support." The loss of verifiable financial support
4 the direct victim would have contributed to surviving dependents
5 that is lost due to the death of the direct victim as a direct
6 result of a crime.

7 * * *

8 "Out-of-pocket loss." The term includes the following losses
9 which shall be reimbursed at a rate set by the Office of
10 Victims' Services:

11 (1) expenses for unreimbursed and unreimbursable
12 expenses or indebtedness incurred for medical care,
13 nonmedical remedial care and treatment as approved by the
14 Office of Victims' Services or other services;

15 (2) expenses for counseling, prosthetic devices,
16 wheelchairs, canes, walkers, hearing aids, eyeglasses or
17 other corrective lenses or dental devices reasonably
18 necessary as a result of the crime upon which the claim is
19 based and for which the claimant either has paid or is
20 liable;

21 (3) expenses related to the reasonable and necessary
22 costs of cleaning the crime scene of a private residence or
23 privately owned motor vehicle. "Cleaning" means to remove or
24 attempt to remove stains or blood caused by the crime or
25 other dirt or debris caused by the processing of the crime
26 scene;

27 (4) expenses resulting from the temporary or permanent
28 relocation of a direct victim and individuals residing in the
29 household of the direct victim due to the incident forming
30 the basis of the victim's claim when there is an immediate

1 need to protect the safety and health of the victim and
2 individuals residing in the household, as verified by a
3 medical provider, human services provider or law enforcement;

4 (5) expenses for physical examinations and materials
5 used to obtain evidence; or

6 (6) other reasonable expenses which are deemed necessary
7 as a direct result of the criminal incident.

8 Except as otherwise provided, the term does not include property
9 damage or pain and suffering.

10 "Personal injury crime." An act, attempt or threat to commit
11 an act which would constitute a misdemeanor or felony under the
12 following:

13 18 Pa.C.S. Ch. 25 (relating to criminal homicide).

14 18 Pa.C.S. Ch. 27 (relating to assault).

15 18 Pa.C.S. Ch. 29 (relating to kidnapping).

16 18 Pa.C.S. Ch. 31 (relating to sexual offenses).

17 18 Pa.C.S. § 3301 (relating to arson and related
18 offenses).

19 18 Pa.C.S. Ch. 37 (relating to robbery).

20 18 Pa.C.S. Ch. 49 Subch. B (relating to victim and
21 witness intimidation).

22 30 Pa.C.S. § 5502.1 (relating to homicide by watercraft
23 while operating under influence).

24 The former 75 Pa.C.S. § 3731 (relating to driving under
25 influence of alcohol or controlled substance) in cases
26 involving bodily injury.

27 75 Pa.C.S. § 3732 (relating to homicide by vehicle).

28 75 Pa.C.S. § 3732.1 (relating to aggravated assault by
29 vehicle).

30 75 Pa.C.S. § 3733 (relating to fleeing or attempting to

1 elude police officer).

2 75 Pa.C.S. § 3734 (relating to driving without lights to
3 avoid identification or arrest).

4 75 Pa.C.S. § 3735 (relating to homicide by vehicle while
5 driving under influence).

6 75 Pa.C.S. § 3735.1 (relating to aggravated assault by
7 vehicle while driving under the influence).

8 75 Pa.C.S. § 3742 (relating to accidents involving death
9 or personal injury).

10 75 Pa.C.S. § 3742.1 (relating to accidents involving
11 death or personal injury while not properly licensed) if the
12 nature and circumstances of the offense committed are
13 substantially similar to an offense under 75 Pa.C.S. § 3742.

14 75 Pa.C.S. Ch. 38 (relating to driving after imbibing
15 alcohol or utilizing drugs) in cases involving bodily injury.
16 The term includes violations of any protective order issued as a
17 result of an act related to domestic violence. The term includes
18 a crime of violence as defined in 42 Pa.C.S. § 9714(g) (relating
19 to sentences for second and subsequent offenses).

20 * * *

21 Section 2. Section 201(11) of the act is amended and the
22 section is amended by adding a paragraph to read:

23 Section 201. Rights.

24 Victims of crime have the following rights:

25 * * *

26 (1.1) If eligible to apply, to be notified of the
27 Address Confidentiality Program under 23 Pa.C.S. Ch. 67
28 (relating to domestic and sexual violence victim address
29 confidentiality).

30 * * *

1 (11) To have assistance in the preparation of,
2 submission of and follow-up on financial assistance claims to
3 the [bureau] Office of Victims' Services.

4 * * *

5 Section 3. Sections 211, 212(b), (c) and (e) and 213(a), (d)
6 and (g) of the act are amended to read:

7 Section 211. Responsibilities of victims of crime under basic
8 bill of rights.

9 [A] Except as provided for victims enrolled in the Address
10 Confidentiality Program under 23 Pa.C.S. Ch. 67 (relating to
11 domestic and sexual violence victim address confidentiality), a
12 victim shall provide a valid address and telephone number and
13 any other required information to all agencies responsible for
14 providing information and notice to the victim. The victim shall
15 be responsible for providing timely notice of any changes in the
16 status of the information. The information provided shall not be
17 disclosed to any person other than a law enforcement agency,
18 corrections agency or prosecutor's office without the prior
19 written consent of the victim.

20 Section 212. Responsibilities of State and local law
21 enforcement agencies.

22 * * *

23 (b) Notice.--

24 (1) [Law enforcement agencies shall within 48 hours of
25 reporting give notice to the direct victim or, if
26 appropriate, a member of the direct victim's family of the
27 availability of crime victims' compensation. The notice
28 required under this subsection shall be in writing and in a
29 manner and form developed by the Office of Victims'
30 Services.] The law enforcement officer responding to or

1 investigating an incident shall provide basic information on
2 the rights and services available for crime victims and the
3 availability of crime victims' compensation to the direct
4 victim or, if appropriate, a member of the direct victim's
5 family. The information shall be provided when the officer
6 has first contact with the victim or as soon as reasonably
7 possible. The information required under this subsection
8 shall be in a written notice in a manner or form developed by
9 the Office of Victims' Services.

10 (2) [Law enforcement agencies shall provide basic
11 information on the rights and services available for crime
12 victims. The information shall be in writing and shall be
13 provided to the victim within 24 hours of the law enforcement
14 agency's first contact with the victim in a manner and form
15 to be developed by the Office of Victims' Services.] Law
16 enforcement agencies shall be responsible for ensuring that
17 officers provide the notification required under paragraph
18 (1).

19 (c) Application.--[The written notification provided for in
20 subsection (b) (1) shall be accompanied by one copy of the
21 application form for crime victims' compensation. Application
22 forms shall be supplied by the Office of Victims' Services to
23 law enforcement agencies. A record of the date of notification
24 shall be maintained by the law enforcement agency.] The Office
25 of Victims' Services shall maintain a mailing list of all local
26 law enforcement agencies and provide law enforcement agencies
27 with forms by which they can order [additional] claim forms. The
28 Office of Victims' Services shall also provide updates to law
29 enforcement agencies on changes which affect their
30 responsibilities under this act.

1 (e) [Forms.--The form developed by the Office of Victims'
2 Services shall be attached to the police report and shall
3 include a victim checkoff signifying that the information has
4 been provided to the crime victim.] Confirmation.--The law
5 enforcement officer responding to or investigating an incident
6 shall indicate on the police report that the information
7 required under subsection (b) was provided to the victim.

8 * * *

9 Section 213. Responsibilities of prosecutor's office.

10 (a) Forms.--The prosecutor's office shall provide the victim
11 of a personal injury crime with all forms developed pursuant to
12 sections 214 and 215 with exception to State cases whereupon the
13 victim advocate shall provide all necessary forms.

14 * * *

15 (d) Release.--[In a personal injury crime, the prosecutor's
16 office shall provide notice of the opportunity to submit input
17 into State correctional release decisions, to receive notice of
18 any release of an adult from a State or local correctional
19 facility and to receive notice of the commitment to a mental
20 health institution from a State or local correctional
21 institution.] The following shall apply:

22 (1) In a personal injury crime, the prosecutor's office
23 shall provide the victim advocate with victim information on
24 all personal injury cases when a State sentence is imposed:

25 (i) so the victim advocate may provide notice of
26 opportunity to submit input into State correctional
27 release decisions;

28 (ii) to provide notice of any release of an adult
29 from a State correctional institution; and

30 (iii) to provide notice of the commitment to a

1 mental health institution from a State correctional
2 institution.

3 (2) In a personal injury crime, the prosecutor's office
4 shall provide notice of any release of an adult from a local
5 correctional institution and provide notice of the commitment
6 to a mental health institution from a local correctional
7 institution.

8 * * *

9 (g) Assistance.--The prosecutor's office shall provide
10 assistance to the victim in all of the following:

11 (1) Preparation of statements under section 201(5).

12 (2) Preparation of, submission of and follow-up on
13 financial assistance claims filed with the [bureau] Office of
14 Victims' Services.

15 (3) Notification to the victim advocate on behalf of the
16 victim for personal injury crimes if the offender is
17 sentenced to a State correctional institution.

18 * * *

19 Section 4. Section 301(c) of the act is amended and the
20 section is amended by adding a subsection to read:

21 Section 301. Office.

22 * * *

23 (c) Service and employees.--The victim advocate shall
24 operate from the central office of the board with such clerical,
25 technical and professional staff as may be available within the
26 budget of the board. The compensation of employees of the office
27 shall be set by the Executive Board. The home address of an
28 employee of the office may not be considered a public record
29 under the act of February 14, 2008 (P.L.6, No.3), known as the
30 Right-to-Know Law.

1 (d) Disclosure and confidentiality.--

2 (1) Each record pertaining to the victim in the
3 possession of or maintained by the office, including
4 information regarding a victim's current contact information
5 and any other information or record relating to the victim,
6 shall be private, confidential and privileged and the
7 property of the office and shall not be subject to the Right-
8 to-Know Law. A record of the office may not be subject to
9 subpoena or discovery, introduced into evidence in a judicial
10 or administrative proceeding or released to the inmate,
11 parolee or probationer.

12 (2) Unless a victim waives the privilege in a signed
13 writing prior to testimony or disclosure, an employee of the
14 office may not be competent nor permitted to testify or to
15 otherwise disclose confidential communications made to or by
16 the employee of the office. The privilege shall terminate
17 upon the death of the victim. Neither the employee of the
18 office nor the victim shall waive the privilege of
19 confidential communications by reporting facts of physical or
20 sexual assault under 23 Pa.C.S. Ch. 63 (relating to child
21 protective services), a Federal or State mandatory reporting
22 statute or a local mandatory reporting ordinance.

23 Section 5. Section 302(5) of the act is amended and the
24 section is amended by adding paragraphs to read:

25 Section 302. Powers and duties of victim advocate.

26 The victim advocate has the following powers and duties:

27 * * *

28 (5) [To act as a liaison with the victim notification
29 program director in the department to coordinate victim
30 notification and services for the department and the board.]

1 The victim advocate is authorized to address the interests of
2 all victims before the board, department or hearing examiner
3 concerning any issues determined appropriate by the victim
4 advocate.

5 (6) To ensure eligible victims are informed of the
6 Address Confidentiality Program under 23 Pa.C.S. Ch. 67
7 (relating to domestic and sexual violence victim address
8 confidentiality).

9 (7) To advocate for the interests of crime victims
10 generally, including the victims of crimes committed by
11 juveniles.

12 Section 6. Section 312(3) of the act is amended to read:
13 Section 312. Powers and duties of Office of Victims' Services.

14 The Office of Victims' Services, subject to approval of the
15 commission, has the following powers and duties:

16 * * *

17 (3) [To adopt, promulgate, amend and rescind suitable
18 rules and regulations to carry out the provisions and
19 purposes of Chapter 7. These regulations shall provide for
20 the approval of attorney fees for representation before the
21 Office of Victims' Services, a hearing examiner or before the
22 Commonwealth Court upon judicial review under section 705.
23 Awards of the attorney fees shall be in addition to awards
24 made to direct victims. Awards of attorney fees shall in no
25 case exceed 15% of the award to the direct victim or victims.
26 It shall be unlawful for an attorney to contract for or
27 receive any sum larger than the amount allowed. Regulations
28 under this paragraph shall include policies, procedures and
29 standards of review regarding claims for compensation;
30 approval or denial of claims, including contributory conduct

1 by direct victims; verification of information and documents;
2 prioritization of review; and all other matters related to
3 the processing.] To adopt, promulgate, amend and rescind
4 suitable regulations to carry out the provisions and purposes
5 of Chapter 7. The regulations shall provide for the
6 following:

7 (i) The approval of attorney fees for representation
8 before the Office of Victims' Services, a hearing
9 examiner or before Commonwealth Court upon judicial
10 review under section 705. Awards of the attorney fees
11 shall be in addition to awards made to direct victims or
12 claimants. Awards of attorney fees may not exceed 15% of
13 the award to the direct victim or claimants. It shall be
14 unlawful for an attorney to contract for or receive a sum
15 larger than the amount allowed under this subparagraph.

16 (ii) Policies, procedures and standards of review
17 regarding claims for compensation.

18 (iii) Approval or denial of claims, including
19 contributory conduct by direct victims.

20 (iv) Verification of information and documents.

21 (v) Prioritization of review.

22 (vi) All other matters related to the processing of
23 claims.

24 * * *

25 Section 7. Section 701(a) of the act is amended by adding
26 paragraphs to read:

27 Section 701. Persons eligible for compensation.

28 (a) General rule.--Except as otherwise provided in this act,
29 the following persons shall be eligible for compensation:

30 * * *

1 (7) Hospitals or other licensed health care providers
2 under section 707(h).

3 (8) A person eligible for counseling under this chapter.

4 * * *

5 Section 8. Sections 702(b), (b.1) and (c), 703, 704(b) (1)
6 and (e) and 706(a) (1) and (b) of the act are amended to read:
7 Section 702. Filing of claims for compensation.

8 * * *

9 (b) Time.--

10 (1) Except as set forth in paragraph (2), a claim must
11 be filed not later than [two] three years after the discovery
12 of the occurrence of the crime upon which the claim is based
13 or not later than [two] three years after the death of the
14 direct victim or intervenor as a result of the crime or the
15 discovery and identification of the body of a murder victim.

16 (2) Exceptions shall be as follows:

17 (ii) If a direct victim is under 18 years of age at
18 the time of the occurrence of the crime and the alleged
19 offender is the direct victim's parent or a person
20 responsible for the direct victim's welfare, an
21 individual residing in the same home as the direct victim
22 or a paramour of the direct victim's parent, all of the
23 following shall apply:

24 (A) The limitation period under this subsection
25 is tolled until the direct victim reaches 21 years of
26 age.

27 (B) The limitation period shall run until the
28 later of:

29 (I) the end of the limitation period for the
30 offense as set forth in 42 Pa.C.S. Ch. 55 Subch.

1 C (relating to criminal proceedings); or
2 (II) the end of the limitation period under
3 paragraph (1).

4 (ii.1) If a direct victim is under 18 years of age
5 at the time of the occurrence of the crime and the direct
6 victim is seeking reimbursement for counseling services
7 only, all of the following shall apply:

8 (A) The limitation period under this subsection
9 is tolled until the direct victim reaches 21 years of
10 age.

11 (B) The limitation period shall run until the
12 later of:

13 (I) the end of the limitation period for the
14 offense as set forth in 42 Pa.C.S. Ch. 55 Subch.
15 C; or

16 (II) the end of the limitation period under
17 paragraph (1).

18 (iii) The Office of Victims' Services may find good
19 cause to accept a claim beyond the limitation period
20 under paragraph (1) if one of the following circumstances
21 existed at the time of the occurrence of the crime or the
22 discovery of the occurrence of the crime:

23 (A) The direct victim, intervenor or claimant
24 was mentally or physically incapacitated.

25 (B) The victim was a minor.

26 (C) There was a fear of retaliation.

27 (D) The occurrence of the crime was not readily
28 apparent.

29 (E) Other circumstances when good cause is shown
30 by the claimant.

1 (b.1) Returned claims.--If a claim has been filed but
2 subsequently returned to the claimant for correction or for
3 additional verification or information, the date the claim was
4 first received by the [bureau] Office of Victims' Services shall
5 be the permanent filing date for purposes of subsection (b). The
6 correction or additional verification or information must be
7 filed within a period of time established by the Office of
8 Victims' Services.

9 (c) Manner.--Claims must be filed with the [bureau] Office
10 of Victims' Services in person, by mail or by any electronic
11 means authorized by the Office of Victims' Services.

12 Section 703. Minimum allowable claim.

13 (a) General rule.--Except as set forth in subsection (b), no
14 award shall be made on a claim unless the claimant has incurred
15 an aggregate minimum out-of-pocket loss, loss of earnings or
16 loss of support of [~~\$100~~] \$50.

17 (b) Exception.--Subsection (a) shall not apply if the direct
18 victim or claimant was 60 years of age or older at the time the
19 crime occurred.

20 Section 704. Determination of claims.

21 * * *

22 (b) Review.--

23 (1) The Office of Victims' Services shall review the
24 claim and all supporting documents and investigate the
25 validity of the claim. The investigation shall include an
26 examination of police, court and official records and reports
27 concerning the crime and may include an examination of
28 medical and hospital reports relating to the injury upon
29 which the claim is based. The Office of Victims' Services may
30 not request or review counseling notes of mental health

1 service providers. The Office of Victims' Services shall
2 request an assessment from the mental health service provider
3 as to the extent the service provided is needed as a direct
4 result of the crime.

5 * * *

6 (e) Records.--The Office of Victims' Services shall maintain
7 complete records and histories on all claims filed, supplemental
8 awards paid to claimants, claims status and third-party
9 entitlements and recoveries in accordance with the commission's
10 established records retention schedule.

11 Section 706. Emergency awards.

12 (a) Authorization.--Notwithstanding the provisions of
13 sections 704 and 707, if it appears to the Office of Victims'
14 Services that the claim is one with respect to which an award
15 probably will be made and that undue hardship will result to the
16 claimant if immediate payment is not made, the Office of
17 Victims' Services may make an emergency award to the claimant
18 pending a final decision in the case. The following shall apply:

19 (1) The total amount of the emergency award shall not
20 exceed [**\$1,500 per claim or at**] a rate set by the Office of
21 Victims' Services.

22 * * *

23 (b) Reconsideration.--The Office of Victims' Services may
24 reconsider an emergency award at any time prior to the final
25 decision in the case and increase previous orders for emergency
26 compensation up to the overall limit of [**\$1,500 per claim or at**]
27 a rate set by the Office of Victims' Services.

28 * * *

29 Section 9. Section 707(a) (3), (a.1) (2), (b) (1), (2), (4) and
30 (4.1), (f) (1) and (3) and (g) of the act are amended and the

1 section is amended by adding a subsection to read:

2 Section 707. Awards.

3 (a) Requirements.--No award shall be made unless it is
4 determined by a preponderance of the evidence that:

5 * * *

6 (3) The crime was promptly reported to the proper
7 authorities. In no case may an award be made if the record
8 shows that the report was made more than 72 hours after the

23 action brought in accordance with 23 Pa.C.S. Ch. 61 (relating to
24 protection from abuse) and as provided for in the Pennsylvania
25 Rules of Civil Procedure. In no case may an award be made if the

28 (2) Filed more than 72 hours after the discovery of the

15 42 Pa.C.S. Ch. 62A (relating to protection of victims of sexual
16 violence or intimidation). An award may not be made if the
17 record shows that the petition was:

18 (1) Withdrawn, unless the Office of Victims' Services
19 finds the withdrawal to have been justified, consistent with
20 regulations of the Office of Victims' Services.

24 (i) the victim is under 18 years of age at the time

9 (ii) an individual responsible for the direct
10 victim's welfare;

11 (iii) an intervenor or individual who is physically
12 present at the crime scene and witnesses a violent crime;

13 (iv) in the case of a homicide, an individual who
14 discovers the body;

15 (v) anyone related to the direct victim within the
16 second degree of consanguinity or affinity;

17 (vi) anyone maintaining a common-law relationship
18 prior to January 2, 2005, with the direct victim;

19 (vii) anyone residing in the same household with the
20 direct victim; or

21 (viii) anyone engaged to be married to the direct
22 victim.

23 (4.1) In the case of an award made pursuant to paragraph

10 (a) County fund.--The county treasurer of each county shall
11 establish and administer a [county offender supervision fund]
12 County Supervision Fee Restricted Receipts Account consisting of
13 the fees collected under this section. The county treasurer
14 shall disperse money from this [fund] account only at the
15 discretion of the president judge of the court of common pleas.
16 The money in this [fund] account shall be used to pay the
17 salaries and employee benefits of all probation and parole
18 personnel employed by the county probation and parole department

5 (b) Excess.--If an amount greater than that paid under
6 Chapter 7 is recovered and collected in such an action, the
7 Commonwealth shall pay the balance to the claimant. The Attorney
8 General shall enforce any subrogation. A claimant who fails to
9 notify the Office of Victims' Services of the receipt of funds
10 from any other claim or award arising out of the crime shall
11 forfeit and pay to the Commonwealth an amount equal to all
12 awards paid by the [bureau] Office of Victims' Services to the
13 claimant or on the claimant's behalf.
