## AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in school health services, furtherproviding for automated external defibrillators and providing 7 for CERTIFICATION OF TEACHERS, REPEALING PROVISIONS RELATING TO CPR INSTRUCTION; AND, IN SCHOOL HEALTH SERVICES, REPEALING 8 PROVISIONS RELATING TO AUTOMATIC EXTERNAL DEFIBRILLATORS AND 9 10 PROVIDING FOR AED AND CPR INSTRUCTION AND PROCEDURE, FOR AUTOMATED EXTERNAL DEFIBRILLATOR PROGRAM, FOR AVAILABILITY 11 AND SPECIFICATIONS OF AUTOMATED EXTERNAL DEFIBRILLATORS AND 12 FOR sudden cardiac event emergency action plan for athletic 13 activities. 14 15 The General Assembly of the Commonwealth of Pennsylvania 16 hereby enacts as follows: 17 Section 1. Section 1423 of the act of March 10, 1949 <--18 (P.L.30, No.14), known as the Public School Code of 1949, is 19 amended by adding a subsection to read: 20 Section 1423. Automated External Defibrillators. 21 (i.3) (1) Each school entity and 22 have an automated external defibrillator present

- 12 <u>automated external defibrillator required under this subsection</u>
- 13 by donation, through a fundraising effort or by any other means.

- 9 (D) FOR PURPOSES OF THIS SECTION, A SCHOOL ENTITY SHALL BE
- 10 DEFINED AS A LOCAL SCHOOL DISTRICT, INTERMEDIATE UNIT OR AREA
- 11 CAREER AND TECHNICAL SCHOOL.
- 12 SECTION 1423. AUTOMATIC EXTERNAL DEFIBRILLATORS.--(A) THE
- 13 DEPARTMENT SHALL ESTABLISH AN AUTOMATIC EXTERNAL DEFIBRILLATOR
- 14 PROGRAM TO ASSIST SCHOOL ENTITIES AND NONPUBLIC SCHOOLS IN
- 15 MAKING AUTOMATIC EXTERNAL DEFIBRILLATORS AVAILABLE IN SCHOOL
- 16 BUILDINGS.
- 17 (B) ON A BIENNIAL BASIS, THE DEPARTMENT, IN CONSULTATION
- 18 WITH THE DEPARTMENT OF GENERAL SERVICES AND THE DEPARTMENT OF
- 19 HEALTH, SHALL ISSUE AN INVITATION TO BID FOR THE COST OF
- 20 AUTOMATIC EXTERNAL DEFIBRILLATORS AND OTHER EQUIPMENT AND
- 21 SUPPLIES NECESSARY FOR THE PROPER OPERATION OF THE DEVICE. THE
- 22 DEPARTMENT SHALL ACCEPT THE BID OF THE LOWEST RESPONSIBLE BIDDER
- 23 AND PERMIT ANY SCHOOL ENTITY OR NONPUBLIC SCHOOL TO PURCHASE THE
- 24 DEVICES AT THE CONTRACT BID PRICE. THE DEPARTMENT MAY PURCHASE
- 25 AUTOMATIC EXTERNAL DEFIBRILLATORS FROM ANY FUNDS APPROPRIATED
- 26 PURSUANT TO SUBSECTION (K) FOR DISTRIBUTION TO SCHOOL ENTITIES
- 27 AND NONPUBLIC SCHOOLS.
- (C) TO BE ELIGIBLE TO OBTAIN OR PURCHASE AUTOMATIC EXTERNAL
- 29 DEFIBRILLATORS UNDER THE PROGRAM A SCHOOL ENTITY OR NONPUBLIC
- 30 SCHOOL MUST:

- 1 (1) ASSURE THAT TWO (2) OR MORE PERSONS ASSIGNED TO THE
- 2 LOCATION WHERE THE AUTOMATIC EXTERNAL DEFIBRILLATOR WILL BE

- 4 (2) ENSURE THAT THE DEVICE WILL BE SECURED IN A SAFE AND
- 5 READILY ACCESSIBLE LOCATION AND AGREE TO PROPERLY MAINTAIN AND
- 6 TEST THE DEVICE ACCORDING TO THE MANUFACTURER'S OPERATIONAL
- 7 GUIDELINES.
- 8 (3) SUBMIT A VALID PRESCRIPTION FOR THE DEVICE FROM A
- 9 LICENSED MEDICAL PRACTITIONER IN THIS COMMONWEALTH.
- 10 (4) AGREE TO PROVIDE THE TRAINING REQUIRED BY SUBSECTION
- 11 (D).
- 12 (D) SCHOOL PERSONNEL WHO ARE EXPECTED TO USE THE AUTOMATIC
- 13 EXTERNAL DEFIBRILLATOR SHALL COMPLETE TRAINING IN
- 14 CARDIOPULMONARY RESUSCITATION AND IN THE USE OF AN AUTOMATIC
- 15 EXTERNAL DEFIBRILLATOR PROVIDED BY THE AMERICAN HEART
- 16 ASSOCIATION, THE AMERICAN RED CROSS OR THROUGH AN EQUIVALENT
- 17 COURSE OF INSTRUCTION APPROVED BY THE DEPARTMENT OF HEALTH.
- 18 (E) A SCHOOL ENTITY MAY INCLUDE THE TRAINING REQUIRED BY
- 19 SUBSECTION (D) IN ITS CONTINUING PROFESSIONAL EDUCATION PLAN
- 20 SUBMITTED TO THE DEPARTMENT UNDER SECTION 1205.1.
- 21 (F) THE PROVISIONS OF 42 PA.C.S. § 8331.2 (RELATING TO GOOD
- 22 SAMARITAN CIVIL IMMUNITY FOR USE OF AUTOMATED EXTERNAL
- 23 DEFIBRILLATOR) SHALL APPLY TO SCHOOL EMPLOYES WHO RENDER CARE
- 24 WITH AN AUTOMATIC EXTERNAL DEFIBRILLATOR.
- 25 (G) FROM FUNDS APPROPRIATED FOR THIS PURPOSE, THE DEPARTMENT
- 26 MAY ASSIST SCHOOL ENTITIES AND NONPUBLIC SCHOOLS THAT ARE NOT
- 27 EQUIPPED WITH AUTOMATIC EXTERNAL DEFIBRILLATORS BY PROVIDING A
- 28 DISCOUNT FROM THE CONTRACT BID PRICE OBTAINED UNDER SUBSECTION
- 29 (B) OR BY PROVIDING AUTOMATIC EXTERNAL DEFIBRILLATORS OBTAINED
- 30 UNDER SUBSECTION (B).

- 1 (G.1) THE PURCHASE OF AN AUTOMATIC EXTERNAL DEFIBRILLATOR
- 2 SHALL BE CONSIDERED AN ALLOWABLE USE OF PENNSYLVANIA
- 3 ACCOUNTABILITY GRANTS UNDER SECTION 2599.2(B).
- 4 (G.2) THE PURCHASE OF AUTOMATIC EXTERNAL DEFIBRILLATORS
- 5 SHALL BE CONSIDERED AN INNOVATIVE EDUCATIONAL PROGRAM UNDER
- 6 ARTICLE XVII-F OF THE ACT OF MARCH 4, 1971 (P.L.6, NO.2), KNOWN
- 7 AS THE "TAX REFORM CODE OF 1971."
- 8 (H) (RESERVED).
- 9 (I) NOT LATER THAN JUNE 30, 2014, AND EACH YEAR THEREAFTER,
- 10 EACH SCHOOL ENTITY SHALL MAKE A REPORT TO THE DEPARTMENT
- 11 DETAILING THE NUMBER, CONDITION, AGE AND PLACEMENT OF AUTOMATIC
- 12 EXTERNAL DEFIBRILLATORS IN EACH SCHOOL BUILDING. AFTER THE
- 13 INITIAL REPORT IS MADE, A SCHOOL ENTITY MAY REPORT THIS
- 14 INFORMATION AS PART OF THE ANNUAL REPORT REQUIRED BY THE
- 15 COMMONWEALTH UNDER SECTION 2505.1 TO RECEIVE STATE REIMBURSEMENT
- 16 FOR HEALTH SERVICES.
- 17 (I.1) A NONPUBLIC SCHOOL THAT PARTICIPATES IN THE AUTOMATIC
- 18 EXTERNAL DEFIBRILLATOR PROGRAM UNDER SUBSECTION (B) OR (G) SHALL
- 19 BE SUBJECT TO THE REPORTING REQUIRED UNDER SUBSECTION (I).
- 20 (I.2) THE DEPARTMENT SHALL ANNUALLY PUBLISH A REPORT ON ITS
- 21 PUBLICLY ACCESSIBLE INTERNET WEBSITE NO LATER THAN DECEMBER 31,
- 22 2014, AND EACH YEAR THEREAFTER. THE REPORT SHALL CONTAIN THE
- 23 FOLLOWING INFORMATION:
- 24 (1) THE TOTAL NUMBER OF AUTOMATIC EXTERNAL DEFIBRILLATORS BY
- 25 SCHOOL ENTITY AND NONPUBLIC SCHOOL.
- 26 (2) THE NUMBER OF SCHOOL BUILDINGS BY SCHOOL ENTITY AND
- 27 NONPUBLIC SCHOOL THAT ARE EQUIPPED WITH AUTOMATIC EXTERNAL
- 28 DEFIBRILLATORS.
- 29 (3) THE NUMBER OF SCHOOL BUILDINGS BY SCHOOL ENTITY AND
- 30 NONPUBLIC SCHOOL THAT ARE NOT EQUIPPED WITH AUTOMATIC EXTERNAL

- 1 DEFIBRILLATORS.
- 2 (J) THE DEPARTMENT MAY ADOPT GUIDELINES AS NECESSARY TO
- 3 ADMINISTER THIS SECTION.
- 4 (K) THE GENERAL ASSEMBLY MAY APPROPRIATE FUNDS TO CARRY OUT
- 5 THE PROVISIONS OF THIS SECTION.

- 20 TAUGHT OR EXTRACURRICULAR ACTIVITIES ARE CONDUCTED ON A REGULAR
- 21 BASIS.
- "SCHOOL ENTITY" MEANS AN AREA CAREER AND TECHNICAL SCHOOL, A
- 23 CHARTER SCHOOL, A CYBER CHARTER SCHOOL, AN INTERMEDIATE UNIT OR
- 24 A SCHOOL DISTRICT.
- 25 "SECRETARY" MEANS THE SECRETARY OF EDUCATION OF THE
- 26 COMMONWEALTH.]

- 11 AMERICAN RED CROSS, AMERICAN HEART ASSOCIATION OR OTHER
- 12 <u>CERTIFYING AGENCY APPROVED BY THE DEPARTMENT OF HEALTH.</u>
- 13 (IV) ANOTHER CERTIFYING AGENCY APPROVED BY THE DEPARTMENT OF
- 14 <u>HEALTH</u>.
- 15 (3) A SCHOOL ENTITY, NONPUBLIC SCHOOL OR PRIVATE SCHOOL, AS
- 16 APPLICABLE, MAY PROVIDE THE INSTRUCTION UNDER THIS SECTION
- 17 THROUGH THE INTERNET OR OTHER ELECTRONIC MEANS.
- 18 (B) THE FOLLOWING APPLY TO AED AND CPR INSTRUCTION:
- 19 (1) EACH SCHOOL ENTITY SHALL ENSURE THAT AT LEAST ONE (1)
- 20 INDIVIDUAL TRAINED AND CERTIFIED IN THE USE OF AN AED AND CPR IS
- 21 PRESENT IN EACH SCHOOL BUILDING DURING EACH SCHOOL DAY.
- 22 (2) EACH SCHOOL NURSE OR DESIGNEE, COACH OF AN ATHLETIC
- 23 ACTIVITY, PHYSICAL EDUCATION TEACHER, ATHLETIC TRAINER AND
- 24 ATHLETIC TRAINING STUDENT AIDE WITHIN EACH SCHOOL ENTITY MUST
- 25 PARTICIPATE IN THE INSTRUCTION IN THE USE OF AN AED AND CPR.
- 26 (3) AN INDIVIDUAL DESCRIBED IN THIS SUBSECTION MUST COMPLETE
- 27 THE INSTRUCTION AND MAINTAIN CERTIFICATION IN THE USE OF AN AED
- 28 IN ACCORDANCE WITH THIS SECTION.
- 29 <u>(C) THE FOLLOWING APPLY TO CONTINUING EDUCATION</u>

- 7 (D) COMPLETION OF INSTRUCTION UNDER SUBSECTIONS (A) AND (B),
- 8 INCLUDING THE TESTING OF SKILLS AND KNOWLEDGE, SHALL BE
- 9 DOCUMENTED BY THE SIGNATURE AND TITLE OF A REPRESENTATIVE OF THE
- 10 TRAINING ENTITY AND SHALL INCLUDE THE DATE THAT THE INSTRUCTION
- 11 WAS COMPLETED. THE DOCUMENTATION SHALL BE RETAINED BY THE SCHOOL
- 12 ENTITY IN THE FILE OF THE EMPLOYE OR VOLUNTEER THAT COMPLETED
- 13 THE TRAINING.
- 14 (E) THE FOLLOWING APPLY TO A CARDIAC EMERGENCY RESPONSE
- 15 PLAN:
- 16 (1) EACH SCHOOL ENTITY, NONPUBLIC SCHOOL OR PRIVATE SCHOOL
- 17 SHALL DEVELOP OR AMEND AN EXISTING CARDIAC EMERGENCY RESPONSE
- 18 PLAN THAT INCLUDES:
- 19 (I) NATIONALLY RECOGNIZED EVIDENCE-BASED CORE ELEMENTS OR
- 20 STANDARDS.
- 21 (II) AN ANNUAL REVIEW.
- 22 (III) SAFETY PROCEDURES TO FOLLOW IN RESPONSE TO A MEDICAL
- 23 EMERGENCY INVOLVING CARDIAC ARREST AND THE USE OF AN AED.
- 24 (IV) THE PLACEMENT OF AEDS ON SCHOOL PREMISES.
- 25 (2) THE CARDIAC EMERGENCY RESPONSE PLAN OF EACH SCHOOL
- 26 ENTITY, NONPUBLIC SCHOOL OR PRIVATE SCHOOL SHALL:
- 27 (I) MAKE AVAILABLE CARDIAC AWARENESS INFORMATION TO SCHOOL
- 28 EMPLOYES AND THOSE RESPONSIBLE FOR EXTRACURRICULAR ACTIVITIES OF
- 29 THE SCHOOL ENTITY.
- 30 (II) REOUIRE CONDUCTING ANNUAL SUDDEN CARDIAC ARREST DRILLS

- 1 WITH OR WITHOUT THE PARTICIPATION OF STUDENTS TO TEST THE
- 2 CARDIAC EMERGENCY RESPONSE PLAN IN RESPONSE TO A SUDDEN CARDIAC
- 3 ARREST.
- 4 (F) AS USED IN THIS SECTION, THE FOLLOWING WORDS AND PHRASES
- 5 SHALL HAVE THE MEANINGS GIVEN TO THEM IN THIS SUBSECTION UNLESS
- 6 THE CONTEXT CLEARLY INDICATES OTHERWISE:
- 7 "ATHLETIC ACTIVITY" MEANS AS DEFINED IN SECTION 1425(H).
- 8 "AUTOMATED EXTERNAL DEFIBRILLATOR" OR "AED" MEANS A PORTABLE
- 9 DEVICE THAT USES ELECTRIC SHOCK TO RESTORE A STABLE HEART RHYTHM
- 10 TO AN INDIVIDUAL IN CARDIAC ARREST.
- "CPR" MEANS CARDIOPULMONARY RESUSCITATION.
- 12 "DEPARTMENT" MEANS THE DEPARTMENT OF EDUCATION OF THE
- 13 <u>COMMONWEALTH.</u>
- 14 "NONPUBLIC SCHOOL" MEANS A NONPROFIT SCHOOL, OTHER THAN A
- 15 PUBLIC SCHOOL WITHIN THIS COMMONWEALTH, WHEREIN A RESIDENT OF
- 16 THIS COMMONWEALTH MAY LEGALLY FULFILL THE COMPULSORY SCHOOL

- 22 LICENSED SCHOOLS ACT.
- 23 "SCHOOL BUILDING" MEANS A BUILDING OWNED BY OR UNDER THE
- 24 CONTROL OF A SCHOOL ENTITY, NONPUBLIC SCHOOL OR PRIVATE SCHOOL
- 25 WHERE CLASSES ARE TAUGHT OR EXTRACURRICULAR ACTIVITIES ARE
- 26 CONDUCTED ON A REGULAR BASIS.
- 27 <u>"SCHOOL DAY" MEANS THE LENGTH OF TIME THAT A CHILD SUBJECT TO</u>
- 28 COMPULSORY SCHOOL ATTENDANCE IS EXPECTED TO BE RECEIVING
- 29 <u>INSTRUCTION DURING A CALENDAR DAY AS DETERMINED BY THE GOVERNING</u>
- 30 BODY.

- 1 "SCHOOL ENTITY" MEANS A SCHOOL DISTRICT, CHARTER SCHOOL,
- 2 REGIONAL CHARTER SCHOOL, CYBER CHARTER SCHOOL, INTERMEDIATE UNIT
- 3 OR AREA CAREER AND TECHNICAL SCHOOL.
