AN ACT

Amending the act of October 21, 1988 (P.L.1036, No.116), entitled "An act establishing the Hardwoods Development 2 Council; conferring powers and duties upon the council; and making an appropriation," further providing for Hardwoods 3 4 Development Council. 5 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: Section 1. Section 4(a) of the act of October 21, 1988 8 9 (P.L.1036, No.116), known as the Hardwoods Development Council 10 Act, is amended to read: Section 4. Council. 11 12 Composition. -- The Hardwoods Development Council is 13 established within the department. The council shall include[, 14 but not be limited to,] the following [25] 27 members: 15 (1) Six members: 16 (i) The Secretary of Agriculture. The Secretary of Community and Economic 17 18 Development.

21	(iv) One representative of veneer manufacturers.
22	(v) [Two representatives] One representative of
23	secondary processors.
24	(vi) [Two] <u>Three</u> representatives of nonprofit
25	corporations which have the purpose to promote and
26	enhance the hardwood industry in this Commonwealth[.], of
27	which one nonprofit corporation shall include the
28	Allegheny National Forest.
29	(vii) One representative of the Pennsylvania Chamber
30	of Business and Industry.
