## AN ACT

- Providing for grants to regional police departments; imposing
  powers and duties on the Center for Local Government Services
  and the Department of Community and Economic Development;
  providing for transfers from the State Gaming Fund; and
  making a related repeal.

  The General Assembly of the Commonwealth of Pennsylvania
  hereby enacts as follows:

  Section 1. Short title.
- 9 This act shall be known and may be cited as the Law
- 10 Enforcement Grant Program Act.
- 11 Section 2. Declaration of policy.
- 12 The General Assembly finds and declares as follows:
- 13 (1) Regional police are the future of local law
- 14 enforcement.
- 15 (2) Regional police provide professional, efficient and 16 local police service to multiple municipalities across this
- 17 Commonwealth.
- 18 (3) An increased number of regional police departments
- 19 would ease the strain on the Pennsylvania State Police, which

- 1 is overtaxed by the growing number of municipalities it
- 2 serves.
- 3 (4) The Commonwealth has chosen to support regional
- 4 police departments by investing in start-up grants for
- 5 regional police departments.
- 6 (5) The Commonwealth has a vested interest in providing
- 7 grants to existing regional police departments to increase
- 8 their financial strength and sustain them after their initial
- 9 start-up period.
- 10 (6) By strengthening regional police departments, the
- 11 Commonwealth improves the safety and security of our
- 12 communities.
- 13 Section 3. Definitions.
- 14 The following words and phrases when used in this act shall
- 15 have the meanings given to them in this section unless the
- 16 context clearly indicates otherwise:
- 17 "Center." The Center for Local Government Services within
- 18 the Department of Community and Economic Development of the
- 19 Commonwealth.
- 20 "Department." The Department of Community and Economic
- 21 Development of the Commonwealth.
- "Grant." A grant awarded to a law enforcement agency in
- 23 accordance with this act.
- "Law enforcement agency." A regional police department.
- 25 "Law enforcement officer." A police officer employed on a
- 26 full-time or part-time basis by a law enforcement agency.
- 27 "Program." The Law Enforcement Grant Program established
- 28 under section 4.
- 29 "Regional police department." A regional police force
- 30 created by two or more municipal corporations under 53 Pa.C.S.

- 2 Section 4. Law Enforcement Grant Program.
- 3 (a) Establishment. -- The Law Enforcement Grant Program is
- 4 established and shall be administered by the center.
- 5 (b) Purpose of grants. -- The center shall award grants to
- 6 eligible law enforcement agencies. Grant funds may be used for
- 7 the following:
- 8 (1) Vehicle acquisition.
- 9 (2) Cameras, including cameras to be placed in vehicles.
- 10 (3) Speed timing devices.
- 11 (4) Uniforms.
- 12 (5) Police and emergency equipment.
- 13 (6) Training.
- 14 (7) Personnel costs.
- 15 (8) Community law enforcement efforts.
- 16 Section 5. Application and review.
- 17 (a) Notice. -- The center shall notify law enforcement
- 18 agencies of the availability of the program by July 1 for fiscal
- 19 years beginning after June 30, 2014.
- 20 (b) Application form. -- The center shall develop and
- 21 distribute a uniform application for applicants to submit for
- 22 grants under the program. The center shall provide the
- 23 application form and accompanying instructions to law
- 24 enforcement agencies annually by September 1.
- 25 (c) Submission of application. -- To be considered, an
- 26 application must be submitted to the center no later than
- 27 November 30 of each fiscal year. The center shall approve or
- 28 disapprove an application within 60 days of the application
- 29 being filed.
- 30 (d) Review. -- The center shall review applications submitted

- 1 for grants under the program and shall approve them if they meet
- 2 the requirements of subsection (e) and the applicant agrees to
- 3 the terms and conditions for the grant as determined by the
- 4 center. A law enforcement agency must submit a signed agreement
- 5 to the center prior to the release of grant funds to the law
- 6 enforcement agency.
- 7 (e) Basis of award.--
- 8 (1) Grants shall be awarded based upon the demonstrated
- 9 need of the law enforcement agency requesting the grant.
- 10 (2) Need shall be calculated based on the total number
- of law enforcement officers employed by the law enforcement
- agency as of July 1 of each fiscal year.
- 13 Section 6. Conditions.
- 14 (a) Claim. -- An applicant for a grant that fails to return a
- 15 signed agreement for the preceding fiscal year is ineligible for
- 16 grant funding in the current fiscal year unless the applicant
- 17 provides to the center a reasonable written explanation as to
- 18 why the applicant failed to claim its grant.
- 19 (b) Compliance. -- An applicant for a grant that fails to
- 20 demonstrate that it complied with all the terms of its agreement
- 21 for the preceding fiscal year is ineligible for grant funding in
- 22 the current fiscal year.
- 23 Section 7. Funding.
- 24 (a) Funding.--Annually, the sum of \$2,000,000 shall be
- 25 transferred from the State Gaming Fund to the department for the
- 26 purpose of issuing grants.
- 27 (b) Administration. -- No money from the transfer under
- 28 subsection (a) may be used for expenses or costs incurred by the
- 29 department for the administration of the program.
- 30 Section 8. Report.

- 1 Within six months of receiving a grant, a law enforcement
- 2 agency shall submit a report to the center. The report shall
- 3 document the use of the grant funds by the law enforcement
- 4 agency.
- 5 Section 9. Guidelines.
- 6 The department shall adopt guidelines necessary to implement
- 7 and administer the provisions of this act.
- 8 Section 10. Repeal.
- 9 (a) Intent.--The General Assembly declares that the repeal
- 10 under subsection (b) is necessary to effectuate this act.
- 11 (b) Repeal.--The provisions of 4 Pa.C.S. § 1408(c) are
- 12 repealed.
- 13 Section 11. Applicability.
- 14 This act shall apply to fiscal years beginning on or after
- 15 July 1, 2014.
- 16 Section 12. Effective date.
- 17 This act shall take effect immediately.
