- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in duties and powers of boards of school directors, providing for broadcast of interscholastic athletic competitions. 6 7 8 This act may be referred to as The Fair Play Broadcasting Act. 10 The General Assembly of the Commonwealth of Pennsylvania 11 hereby enacts as follows: 12 Section 1. The act of March 10, 1949 (P.L.30, No.14), known 13 as the Public School Code of 1949, is amended by adding a 14 section to read: 15 Section 525.1. - 7 (2) The visiting team has a curricular program for secondary
- 8 school students that typically provides radio broadcasting,
- 9 video streaming or telegraphic play-by-play for the visiting
- 10 team's home games.
- 11 (b) The provisions of this section shall apply to
- 12 <u>interscholastic athletic competitions beginning in the 2023-2024</u>
- 13 school year.
- (c) As used in this section, the following words and phrases
- 15 <u>shall have the meanings given to them in this subsection unless</u>
- 16 the context clearly indicates otherwise:
- 17 "Interscholastic athletic competition" shall mean an athletic
- 18 competition conducted between or among school entities situated
- 19 <u>in counties of the second class, second class A, third class,</u>
- 20 fourth class, fifth class, sixth class, seventh class and eighth
- 21 class.
- 22 "Nonpublic school" shall mean a school, other than a public
- 23 <u>school within this Commonwealth</u>, where a resident of this
- 24 Commonwealth may legally fulfill the compulsory school
- 25 attendance requirements of this act and Title VI of the Civil
- 26 Rights Act of 1964 (Public Law 88-352, 78 Stat. 241).
- 27 "School entity" shall mean a public school, school district,
- 28 nonpublic school or private school in this Commonwealth, other
- 29 than a private or nonpublic school which elects not to become a
- 30 member of the Pennsylvania Interscholastic Athletic Association,

- 1 that provides interscholastic athletic competition opportunities
- 2 <u>for secondary school students.</u>
- 3 "Secondary school student" shall mean a student who attends a
- 4 school entity in grades seven through twelve.
- 5 Section 2. This act shall take effect immediately.
