AN ACT

- Requiring persons convicted of arson and related offenses to 1 2
- register with local authorities; providing for duties of the Pennsylvania State Police and the Pennsylvania Board of 3
- Probation and Parole; and imposing a penalty.
- The General Assembly of the Commonwealth of Pennsylvania 5
- hereby enacts as follows:
- 7 Section 1. Short title.
- This act shall be known and may be cited as the Convicted 8
- Arsonist Registry Act.
- Section 2. Findings. 10
- 11 The General Assembly finds and declares as follows:
- 12 Following a first arson or related offense,
- convicted arsonists continue to commit these violent crimes. 1.3
- 14 This Commonwealth experienced 1,684 reported arsons
- 15 during 2013.
- 16 This Commonwealth experienced 9,474 arsons from 2009
- through 2013. 17
- In this Commonwealth there were 482 arrests for 18 (4)

- 1 arson offenses in 2013.
- 2 (5) This Commonwealth's arrest rate of 4.6 arrests for
- arson per 100,000 inhabitants was greater than the national
- 4 and northeast region rates.
- 5 (6) In an effort to stymie future offenses, a database
- of convicted arsonists needs to be maintained. Requiring
- 7 registration will assist in criminal investigation and
- 8 prevention. The registry will be at the disposal of local
- 9 authorities.
- 10 (7) Other databases, such as sex offender registries,
- 11 serve to protect the public, as should an arsonist registry.
- 12 Section 3. Definitions.
- 13 The following words and phrases when used in this act shall
- 14 have the meanings given to them in this section unless the
- 15 context clearly indicates otherwise:
- 16 "Convicted arsonist." An individual who has been:
- 17 (1) Convicted or adjudicated delinquent for a violation
- of 18 Pa.C.S. § 3301(a), (c), (d) or (f) (relating to arson
- and related offenses) or an equivalent offense under Federal
- law or the law of another jurisdiction.
- 21 (2) Convicted of an attempt to commit an offense under
- 22 paragraph (1).
- 23 Section 4. Registration required.
- 24 (a) General rule.--
- 25 (1) Except as set forth under paragraph (2), a convicted
- arsonist is subject to lifetime registration in the manner
- 27 prescribed by this section.
- 28 (2) A juvenile offender is subject to registration in
- 29 accordance with this act until the offender has attained 25
- 30 years of age, at which time all records related to the

- 1 registration of the juvenile offender shall be destroyed.
- 2 (b) Information to be provided. -- A registration shall
- 3 consist, at a minimum, of the convicted arsonist's:
- 4 (1) Name.
- 5 (2) Social Security number.
- 6 (3) All current or intended residences and all
- 7 information concerning current or intended enrollment as a
- 8 student.
- 9 (4) Photographs and fingerprinting as set forth under
- 10 section 6.
- 11 (c) Procedure.--
- 12 (1) A convicted arsonist is required to register with
- the Pennsylvania State Police within 14 days of release from
- incarceration, parole from a State or county correctional
- institution or the commencement of a sentence of intermediate
- punishment or probation or, if the conviction occurred in
- another jurisdiction, within 14 days of arrival in this
- 18 Commonwealth.
- 19 (2) A convicted arsonist shall inform the Pennsylvania
- 20 State Police of:
- 21 (i) Any change of residence or establishment of an
- 22 additional residence.
- 23 (ii) Any change of institution or location at which
- the person is enrolled as a student or termination of
- enrollment.
- 26 (iii) Becoming enrolled as a student if the
- individual has not previously provided that information
- to the Pennsylvania State Police.
- 29 Section 5. Registration information to local authorities.
- 30 (a) Provision of information. -- The Pennsylvania State Police

- 1 shall provide the information obtained under section 4 to the
- 2 fire chiefs and the chief law enforcement officers of the police
- 3 departments of the municipalities in which the individual will
- 4 reside or be enrolled as a student. In addition, the
- 5 Pennsylvania State Police shall provide the fire chiefs and the
- 6 chief law enforcement officers with the address at which the
- 7 individual will reside or be enrolled as a student following the
- 8 individual's release from incarceration, parole or probation.
- 9 (b) Notice of failure to comply. -- The Pennsylvania State
- 10 Police shall provide notice to the fire chiefs and the chief law
- 11 enforcement officers of the police departments of the
- 12 municipalities notified under subsection (a) when an individual
- 13 fails to comply with the registration requirements of this act
- 14 and request, as appropriate, that the police departments assist
- 15 in locating and apprehending the individual.
- 16 (c) Additional notice requirement. -- The Pennsylvania State
- 17 Police shall provide notice to the fire chiefs and the chief law
- 18 enforcement officers of the police departments of the
- 19 municipalities notified under subsection (a) when the
- 20 Pennsylvania State Police is in receipt of information
- 21 indicating the individual will no longer reside or be enrolled
- 22 as a student in the municipality.
- 23 Section 6. Photographs and fingerprinting.
- 24 An individual subject to section 4 shall register and submit
- 25 to fingerprinting and photographing as required by this act at
- 26 approved registration sites. Fingerprinting shall, at a minimum,
- 27 require submission of a full set of fingerprints. Photographing
- 28 shall, at a minimum, require submission to photographs of the
- 29 face and any scars, marks, tattoos or other unique features of
- 30 the individual.

- 1 Section 7. Penalty.
- 2 An individual subject to registration under section 4 who
- 3 fails to register with the Pennsylvania State Police as required
- 4 under this act commits a misdemeanor of the third degree.
- 5 Section 8. Sentencing court information.
- 6 The sentencing court shall inform a convicted arsonist at the
- 7 time of sentencing of the provisions of this act. The court
- 8 shall:
- 9 (1) Specifically inform the convicted arsonist of the
- 10 duty to register and provide the information required for
- 11 each registration.
- 12 (2) Specifically inform the convicted arsonist of the
- duty to inform the Pennsylvania State Police within 14 days
- if the convicted arsonist changes residence, establishes an
- 15 additional residence or changes the institution or location
- at which the person is enrolled as a student or terminates
- 17 enrollment.
- 18 (3) Specifically inform the convicted arsonist of the
- duty to inform the Pennsylvania State Police within 14 days
- of becoming enrolled as a student if the convicted arsonist
- 21 has not previously provided that information to the
- 22 Pennsylvania State Police.
- 23 (4) Order the fingerprints and photograph of the
- convicted arsonist to be provided to the Pennsylvania State
- 25 Police upon sentencing.
- 26 (5) Require the convicted arsonist to sign a form
- 27 stating that the duty to register under this act has been
- 28 explained.
- 29 Section 9. Duties of Pennsylvania State Police.
- 30 The Pennsylvania State Police shall:

- 1 (1) Create and maintain a State registry of convicted arsonists.
- 3 In consultation with the Department of Corrections, the Office of Attorney General and the Pennsylvania Board of 4 5 Probation and Parole, promulgate guidelines necessary for the general administration of this act. These guidelines shall 6 7 establish procedures to allow an individual subject to the 8 registration to fulfill these requirements at approved 9 registration sites throughout this Commonwealth. The 10 Pennsylvania State Police shall publish a list of approved 11 registration sites in the Pennsylvania Bulletin and provide a 12 list of approved registration sites in any notices sent to 13 individuals required to register under section 4.
 - (3) Notify, within five days of receiving the convicted arsonist's registration, the fire chiefs and the chief law enforcement officers of the police departments having primary jurisdiction of the municipalities in which a convicted arsonist resides or is enrolled as a student of the fact that the convicted arsonist has been registered with the Pennsylvania State Police under this act.
- 21 Section 10. Duties of Pennsylvania Board of Probation and 22 Parole.
- 23 The Pennsylvania Board of Probation and Parole shall:
- 24 (1) Create a notification form which will inform State 25 and county prison and probation and parole personnel how to 26 inform convicted arsonists required to register under this 27 act of their duty under the law.
- 28 (2) In cooperation with the Department of Corrections
 29 and other Commonwealth agencies, obtain the following
 30 information regarding a convicted arsonist:

- 1 (i) Name, including any aliases.
- 2 (ii) Identifying factors.
- 3 (iii) Anticipated future residence.
- 4 (iv) Offense history.
- 5 (v) Photograph of the convicted arsonist.
- 6 (3) Immediately transmit the information under paragraph
- 7 (2) to the Pennsylvania State Police for immediate entry into
- 8 the State registry of convicted arsonists.
- 9 Section 11. Availability of registration information.
- 10 The registration information obtained under this act shall
- 11 not be open to inspection by the public or by any person other
- 12 than a law enforcement officer, fire chief or individual charged
- 13 with the investigation of a fire.
- 14 Section 12. Applicability.
- This act shall apply to individuals convicted or adjudicated
- 16 delinquent on or after the effective date of this section for an
- 17 offense requiring registration under this act.
- 18 Section 13. Effective date.
- 19 This act shall take effect in 60 days.
