## AN ACT

- 1 Amending Titles 18 (Crimes and Offenses) and 42 (Judiciary and
- Judicial Procedure) of the Pennsylvania Consolidated Statutes, providing for animal hoarding.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 5511 of Title 18 of the Pennsylvania
- 7 Consolidated Statutes is amended by adding a subsection to read:
- 8 § 5511. Cruelty to animals.
- 9 \* \* \*
- 10 (h.2) Animal hoarding. -- A person commits a misdemeanor of
- 11 the third degree if the person maintains animals on real
- 12 property and that maintenance results in unsanitary,
- 13 <u>unhealthful</u>, <u>malodorous</u>, <u>or dangerous conditions for an</u>
- 14 individual, the animals or real or personal property. Each
- 15 animal maintained in violation of this subsection constitutes a
- 16 separate offense.

- 18 Section 2. Title 42 is amended by adding a section to read:

- 1 § 9720.5. Animal hoarding.
- 2 The following apply to sentencing for an offense under 18
- 3 Pa.C.S. § 5511(h.2) (relating to cruelty to animals):
- 4 (1) Prior to sentencing the defendant, the court shall
- 5 <u>order an evaluation to be performed by a mental health</u>
- 6 professional to determine if the defendant, at the time of
- 7 the commission of the offense, suffered from or acted in
- 8 <u>accordance with a psychological or psychiatric disability.</u>
- 9 (2) Sentencing shall not be scheduled until at least ten
- 10 <u>days after distribution of the evaluation under paragraph</u>
- 11 (1).
- 12 (3) At sentencing, if the court finds by a preponderance
- of evidence that defendant, at the time of the commission of
- the offense, suffered from or acted in accordance with a
- 15 <u>psychological or psychiatric disability, the court shall:</u>
- 16 (i) order the defendant to:
- 17 (A) undergo treatment appropriate to the
- 18 <u>diagnosis; and</u>
- 19 (B) to submit a report of the treatment; and
- 20 (ii) stay the action against the defendant pending
- 21 submission of the report under subparagraph (i) (B).
- 22 (4) Upon review of the report under paragraph (3)(i)(B),
- 23 if the court determines by a preponderance of the evidence
- that the treatment under subparagraph (i) (A) is successful,
- 25 the court shall do all of the following:
- 26 (i) Order forfeiture under 18 Pa.C.S. § 5511 (m).
- 27 (ii) Order prohibition of ownership under 18 Pa.C.S.
- 28 § 5511(m.2).
- 29 (iii) Reverse the conviction.
- 30 (iv) Order expungement under Pa.R.Crim.P. 790
