A RESOLUTION

- 1 Recognizing the month of March 2013 as "Intellectual
- Disabilities Awareness Month" in Pennsylvania.
- 3 WHEREAS, An intellectual disability is a particular state of
- 4 functioning that may be genetic, neurological or the result of a
- 5 traumatic life event; and
- 6 WHEREAS, Intellectual disabilities are characterized by
- 7 limitation in intelligence and adaptive skills; and
- 8 WHEREAS, Intellectual disabilities are not mental illness;
- 9 and
- 10 WHEREAS, There are no known medical, social or educational
- 11 interventions that can cure intellectual disabilities, although
- 12 each service can and does dramatically improve skills and
- 13 adaptive functioning; and

- 1 WHEREAS, Individuals with intellectual disabilities deserve
- 2 and require lifelong support and services; and
- 3 WHEREAS, The United States Supreme Court, in its Olmstead
- 4 decision, affirmed the right of individuals with disabilities,
- 5 including intellectual disabilities and other developmental
- 6 disabilities, to receive community-based services as an
- 7 alternative to institutional care; and
- 8 WHEREAS, Almost 54,699 Pennsylvanians with intellectual
- 9 disabilities received services and support in fiscal year 2012--
- 10 2013; and
- 11 WHEREAS, More than 31,500 children, including significant
- 12 numbers of children who have intellectual disabilities, received
- 13 early intervention services in fiscal year 2012-2013 and an
- 14 additional 15,335 individuals with intellectual disabilities
- 15 continue to wait for services; and
- 16 WHEREAS, These services and support ensure that all citizens
- 17 of this Commonwealth who have intellectual disabilities have the
- 18 opportunity to participate in the range of life experiences we
- 19 all enjoy in our homes and communities, such as inclusion in
- 20 schools, neighborhoods, businesses and places of worship; and
- 21 WHEREAS, Public awareness and education improve the
- 22 community's understanding of intellectual disabilities and the
- 23 services and support needed to meet the specific needs and
- 24 abilities of people with intellectual disabilities; therefore be
- 25 it
- 26 RESOLVED, That the House of Representatives acknowledge the
- 27 important role of public awareness and education in improving
- 28 the lives of individuals with intellectual disabilities and
- 29 recognize the month of March 2013 as "Intellectual Disabilities
- 30 Awareness Month" in Pennsylvania; and be it further

- 1 RESOLVED, That the House of Representatives express
- 2 appreciation to all those Pennsylvanians who conduct special
- 3 outreach, education and services during the month of March and
- 4 hereby urge the citizens of this Commonwealth to give year-round
- 5 support to efforts which enable people with intellectual
- 6 disabilities to live full and productive lives in our
- 7 communities.
