A RESOLUTION

- Designating the day of July 26, 2013, as "Americans with Disabilities Act Awareness Day" in Pennsylvania.
- 3 WHEREAS, The Americans with Disabilities Act of 1990, (Public
- 4 Law 101-336, 104 Stat. 327) (ADA) was passed on July 26, 1990 to
- 5 ensure the civil rights of citizens with disabilities; and
- 6 WHEREAS, The Centers for Disease Control and Prevention
- 7 estimates that there are 475,000 people with a disability living
- 8 in this Commonwealth; and
- 9 WHEREAS, The Commonwealth affirms the principles of equality
- 10 and inclusion for persons with disabilities as set forth and
- 11 embodied in the ADA; and
- 12 WHEREAS, The ADA is a thorough civil rights law which
- 13 prohibits discrimination against people with disabilities in the
- 14 areas of employment, public entities, accommodations and
- 15 telecommunications; and

- 1 WHEREAS, Numerous organizations in this Commonwealth work
- 2 with constituents and communities to bring forth the promise of
- 3 hope and freedom that is envisioned by the passage of the ADA;
- 4 and
- 5 WHEREAS, July 26, 2013, celebrates the 23rd anniversary of
- 6 the Americans with Disabilities Act; therefore be it
- 7 RESOLVED, That the House of Representatives designate the day
- 8 of July 26, 2013, as "Americans with Disabilities Act Awareness
- 9 Day" in Pennsylvania; and be it further
- 10 RESOLVED, That the Commonwealth officially recognize the
- 11 importance of raising awareness to the significance of the
- 12 Americans with Disabilities Act.
