A RESOLUTION

- Designating October 2013 as "Down Syndrome Awareness Month" in Pennsylvania.
- 3 WHEREAS, Down syndrome is a genetic condition that occurs in
- 4 approximately one in every 800 births; and
- 5 WHEREAS, The most common form of Down syndrome, Trisomy 21,
- 6 is due to an error in cell division, just prior to or during
- 7 conception, with the 21st chromosome dividing in three instead
- 8 of two, resulting in a person's being born with 47 instead of 46
- 9 chromosomes in each cell; and
- 10 WHEREAS, There are more than 400,000 people of various
- 11 ethnic, racial, religious and socioeconomic groups with Down
- 12 syndrome living in the United States; and

- 1 WHEREAS, While people with Down syndrome are at a higher risk
- 2 for various conditions, such as congenital heart defects,
- 3 respiratory problems and thyroid issues, advances in treatments
- 4 enable them to lead healthy lives; and
- 5 WHEREAS, Thanks to these medical treatments and continuing
- 6 research, life expectancy for people with Down syndrome has
- 7 increased from 25 years of age in 1983 to 60 years of age today;
- 8 and
- 9 WHEREAS, Early intervention, appropriate speech, physical and
- 10 occupational therapies and quality education programs enable
- 11 people with Down syndrome to adapt and thrive; and
- 12 WHEREAS, With such programs and the support of their families
- 13 and communities, people with Down syndrome attend school,
- 14 participate in postsecondary opportunities, with many going on
- 15 to college, obtain full-time employment, enter into marriage and
- 16 fully participate in their communities; therefore be it
- 17 RESOLVED, That the House of Representatives designate October
- 18 2013 as "Down Syndrome Awareness Month" in Pennsylvania,
- 19 recognizing the positive contributions that people with Down
- 20 syndrome and their families make to our communities in the
- 21 United States and Pennsylvania.
