| 12 | Section 1. Section 1554 of the act of March 10, 1949 < |
| 13 | (P.L.30, No.14), known as the Public School Code of 1949, is |
| 14 | amended to read: |
| 15 | Section 1554. Holocaust, Genocide and Human Rights |
| 16 | Violations Instruction (a) (1) Beginning with school year |
| 17 | [2015-2016] <u>2025-2026</u> , each school entity [may] <u>shall</u> offer |
| 18 | instruction in the Holocaust, genocide and human rights |
| 19 | violations to students. The instruction shall equate to at least |
| 20 | seven hours within a school year and be integrated within the |
| 21 | social studies and language arts courses of study required in |

- 1 accordance with State Board of Education regulations.
- 2 Instruction may also be integrated into other appropriate
- 3 courses of study.
- 4 (2) The Holocaust, genocide and human rights violations-
- 5 instruction permitted pursuant to paragraph (1) shall:
- 6 (i) Be age appropriate.
- 7 (ii) Be sequential in method of study.
- 8 (iii) Communicate the connection between national, ethnic,
- 9 racial or religious intolerance and the subjects described in
- 10 subsection (b).
- 11 (iv) Communicate the impact of personal responsibility,
- 12 civic engagement and societal response within the context of the-
- 13 subjects described in subsection (b).
- 14 (3) School entities may utilize any appropriate public or
- 15 private materials, personnel and other resources in developing
- 16 and implementing the program of instruction permitted pursuant-
- 17 to paragraph (1). The Department of Education shall distribute
- 18 information about appropriate curriculum materials to each
- 19 school entity. School entities may utilize any curriculum that
- 20 complies with the requirements of this subsection.
- 21 (b) (1) The Department of Education shall establish
- 22 curriculum guidelines no later than twelve (12) months after the-
- 23 effective date of this section. The guidelines shall encourage
- 24 the inclusion of all of the following subjects where appropriate
- 25 in the instruction:
- 26 (i) The breadth of the history of the Holocaust, including
- 27 the Third Reich dictatorship, concentration camp system,
- 28 persecution of Jews and non-Jews, Jewish and non-Jewish-
- 29 resistance and post-World War II trials.
- 30 (ii) The definition, history, response and actions taken in-

- 1 the face of genocide, including the Holocaust and any other-
- 2 genocide perpetrated against humanity, including the Rwandan
- 3 genocide and other genocides committed in Africa, Asia and
- 4 Europe.
- 5 (iii) Human rights violations.
- 6 (iv) Anti-Semitism, racism and the abridgment of civil-
- 7 rights.
- 8 (2) The Department of Education shall work in consultation
- 9 with organizations and individuals that provide educational
- 10 expertise and resources related to the Holocaust, genocide and
- 11 human rights violations to develop the curriculum guidelines.
- 12 The guidelines shall state the minimum amount of instruction
- 13 necessary to adequately educate students on the Holocaust,
- 14 genocide and human rights violations. The guidelines shall be
- 15 posted on the Department of Education's publicly accessible
- 16 <u>Internet website.</u>
- 17 (c) Beginning with the 2015-2016 school year, the Department-
- 18 of Education shall make available, to all school entities, in-
- 19 service training programs based upon the instruction provided
- 20 for under subsection (a) and the curriculum quidelines
- 21 established pursuant to subsection (b).
- 22 (d) (1) Beginning with the 2015-2016 school year, each
- 23 school entity providing instruction under subsection (a) shall-
- 24 provide, as part of its in-service training, programs on the-
- 25 Holocaust, genocide and human rights violations for all
- 26 instructors whose teaching responsibilities include courses of
- 27 study in which instruction concerning the Holocaust, genocide
- 28 and human rights violations is integrated. A school entity may
- 29 utilize the programs made available by the Department of
- 30 Education or use other alternative programs that are consistent-

- 1 with the provisions of this section.
- 2 (2) Employes required to complete continuing professional
- 3 education under section 1205.2 shall receive credit toward the
- 4 continuing professional education requirements where the
- 5 training program provided pursuant to paragraph (1) has been
- 6 approved by the Department of Education.
- 7 (e) The Department of Education shall provide the
- 8 guidelines, in service training and any other materials-
- 9 developed in accordance with this section to any nonpublic-
- 10 school within this Commonwealth upon receiving a request from
- 11 the nonpublic school.
- 12 (f) The State Board of Education shall:
- (1) Conduct a study regarding the manner in which
- 14 instruction in the Holocaust, genocide and human rights-
- 15 violations is offered by school entities in this Commonwealth.
- 16 In conducting the study, the State Board of Education shall-
- 17 request that each school entity provide the State Board of
- 18 Education with information concerning whether the school entity-
- 19 offers such instruction and the manner in which such instruction
- 20 is offered. Each school entity shall provide information to the
- 21 State Board of Education in response to a request under this
- 22 paragraph. Following the [2016-2017] 2026-2027 school year, but-
- 23 not later than November 30, [2017] 2027, the State Board of
- 24 Education shall issue a report to the Governor, the Secretary of
- 25 Education, the Chairman and Minority Chairman of the Education
- 26 Committee of the Senate and the Chairman and Minority Chairman
- 27 of the Education Committee of the House of Representatives-
- 28 addressing the following:
- 29 (i) The number of school entities offering instruction in
- 30 the Holocaust, genocide and human rights violations.

- 1 (ii) The number of school entities using the curriculum
- 2 guidelines established by the Department of Education under-
- 3 subsection (b).
- 4 (iii) The number of school entities using the in-service-
- 5 training programs made available by the Department of Education-
- 6 under subsection (c).
- 7 (iv) A description of the manner in which school entities
- 8 are offering instruction in the Holocaust, genocide and human
- 9 rights violations, including the number of hours of instruction-
- 10 offered, the grade levels at which such instruction is offered
- 11 and the course within such instruction is integrated.
- 12 (v) The recommendations for improvements to the offering of
- 13 instruction in the Holocaust, genocide and human rights
- 14 violations, including recommended legislation.
- 15 (2) Adopt a regulation, pursuant to the act of June 25, 1982
- 16 (P.L.633, No.181), known as the "Regulatory Review Act," to
- 17 require school entities to offer instruction in the Holocaust,
- 18 genocide and human rights violations that is consistent with
- 19 subsections (a) and (b) [, if the study conducted by the State-
- 20 Board of Education under paragraph (1) demonstrates that less
- 21 than ninety percent of the school entities are offering-
- 22 instruction in the Holocaust, genocide and human rights-
- 23 violations consistent with subsections (a) and (b)].
- 24 (3) Adopt rules and regulations necessary for the
- 25 implementation of this section pursuant to the "Regulatory"
- 26 Review Act."
- 27 (g) [For purposes of this section, the term "school entity"
- 28 shall mean a school district, charter school, regional charter
- 29 school, cyber charter school, intermediate unit or area career
- 30 and technical school.] The following shall apply to curriculum

- 1 <u>transparency:</u>
- 2 (1) Beginning with the 2025-2026 school year and each school
- 3 vear thereafter, a school entity shall post an Internet link or
- 4 title for every textbook used by the school entity, a course
- 5 syllabus or a written summary of the Holocaust, genocide and
- 6 human rights violations curriculum offered by the school entity
- 7 on the school entity's publicly accessible Internet website.
- 8 <u>(2) The chief school administrator or a designee shall be</u>
- 9 <u>responsible for implementing the requirements under this</u>
- 10 subsection.
- 11 (3) The requirements of this subsection shall not be
- 12 <u>construed to require a school entity to violate the copyright,</u>
- 13 <u>trademark or other intellectual property right of the creator or</u>
- 14 <u>owner of the curriculum.</u>
- 15 (h) As used in this section, the following words and phrases
- 16 <u>shall have the meanings given to them in this subsection unless</u>
- 17 the context clearly indicates otherwise:
- 18 "Genocide." The term includes any of the following acts
- 19 committed with the intent to destroy, in whole or in part, a
- 20 <u>national</u>, <u>ethnic</u>, <u>racial or religious group</u>:
- 21 (1) Killing members of the group.
- 22 (2) Causing serious bodily or mental harm to members of the
- 23 group.
- 24 (3) Deliberately inflicting on the group conditions of life
- 25 <u>calculated to bring about the group's physical destruction, in</u>
- 26 whole or in part.
- 27 <u>(4) Imposing measures intended to prevent births within the</u>
- 28 group.
- 29 (5) Forcibly transferring children of the group to another
- 30 group.

- 1 <u>"Holocaust." The systematic, state sponsored persecution and</u>
- 2 <u>attempted annihilation of Jewish individuals and other groups by</u>
- 3 the Nazi regime in Germany between 1933 and 1945, which resulted
- 4 in the murder of approximately six million (6,000,000) Jewish
- 5 individuals and five million (5,000,000) other individuals.
- 6 <u>"School entity." A school district, charter school, regional</u>
- 7 charter school, cyber charter school or intermediate unit.
- 8 Section 2. This act shall take effect in 60 days.
- 9 SECTION 1. SECTION 1554 OF THE ACT OF MARCH 10, 1949
- 10 (P.L.30, NO.14), KNOWN AS THE PUBLIC SCHOOL CODE OF 1949, IS
- 11 REPEALED:
- 12 [SECTION 1554. HOLOCAUST, GENOCIDE AND HUMAN RIGHTS
- 13 VIOLATIONS INSTRUCTION. -- (A) (1) BEGINNING WITH SCHOOL YEAR
- 14 2015-2016, EACH SCHOOL ENTITY MAY OFFER INSTRUCTION IN THE
- 15 HOLOCAUST, GENOCIDE AND HUMAN RIGHTS VIOLATIONS TO STUDENTS. THE
- 16 INSTRUCTION SHALL BE INTEGRATED WITHIN THE SOCIAL STUDIES AND
- 17 LANGUAGE ARTS COURSES OF STUDY REQUIRED IN ACCORDANCE WITH STATE
- 18 BOARD OF EDUCATION REGULATIONS. INSTRUCTION MAY ALSO BE
- 19 INTEGRATED INTO OTHER APPROPRIATE COURSES OF STUDY.
- 20 (2) THE HOLOCAUST, GENOCIDE AND HUMAN RIGHTS VIOLATIONS
- 21 INSTRUCTION PERMITTED PURSUANT TO PARAGRAPH (1) SHALL:
- 22 (I) BE AGE APPROPRIATE.
- 23 (II) BE SEQUENTIAL IN METHOD OF STUDY.
- (III) COMMUNICATE THE CONNECTION BETWEEN NATIONAL, ETHNIC,
- 25 RACIAL OR RELIGIOUS INTOLERANCE AND THE SUBJECTS DESCRIBED IN
- 26 SUBSECTION (B).
- 27 (IV) COMMUNICATE THE IMPACT OF PERSONAL RESPONSIBILITY,
- 28 CIVIC ENGAGEMENT AND SOCIETAL RESPONSE WITHIN THE CONTEXT OF THE
- 29 SUBJECTS DESCRIBED IN SUBSECTION (B).
- 30 (3) SCHOOL ENTITIES MAY UTILIZE ANY APPROPRIATE PUBLIC OR

- 1 PRIVATE MATERIALS, PERSONNEL AND OTHER RESOURCES IN DEVELOPING
- 2 AND IMPLEMENTING THE PROGRAM OF INSTRUCTION PERMITTED PURSUANT
- 3 TO PARAGRAPH (1). THE DEPARTMENT OF EDUCATION SHALL DISTRIBUTE
- 4 INFORMATION ABOUT APPROPRIATE CURRICULUM MATERIALS TO EACH
- 5 SCHOOL ENTITY. SCHOOL ENTITIES MAY UTILIZE ANY CURRICULUM THAT
- 6 COMPLIES WITH THE REQUIREMENTS OF THIS SUBSECTION.
- 7 (B) (1) THE DEPARTMENT OF EDUCATION SHALL ESTABLISH
- 8 CURRICULUM GUIDELINES NO LATER THAN TWELVE (12) MONTHS AFTER THE
- 9 EFFECTIVE DATE OF THIS SECTION. THE GUIDELINES SHALL ENCOURAGE
- 10 THE INCLUSION OF ALL OF THE FOLLOWING SUBJECTS WHERE APPROPRIATE
- 11 IN THE INSTRUCTION:
- 12 (I) THE BREADTH OF THE HISTORY OF THE HOLOCAUST, INCLUDING
- 13 THE THIRD REICH DICTATORSHIP, CONCENTRATION CAMP SYSTEM,
- 14 PERSECUTION OF JEWS AND NON-JEWS, JEWISH AND NON-JEWISH
- 15 RESISTANCE AND POST-WORLD WAR II TRIALS.
- 16 (II) THE DEFINITION, HISTORY, RESPONSE AND ACTIONS TAKEN IN
- 17 THE FACE OF GENOCIDE, INCLUDING THE HOLOCAUST AND ANY OTHER
- 18 GENOCIDE PERPETRATED AGAINST HUMANITY, INCLUDING THE RWANDAN
- 19 GENOCIDE AND OTHER GENOCIDES COMMITTED IN AFRICA, ASIA AND
- 20 EUROPE.
- 21 (III) HUMAN RIGHTS VIOLATIONS.
- 22 (IV) ANTI-SEMITISM, RACISM AND THE ABRIDGMENT OF CIVIL
- 23 RIGHTS.
- 24 (2) THE DEPARTMENT OF EDUCATION SHALL WORK IN CONSULTATION
- 25 WITH ORGANIZATIONS AND INDIVIDUALS THAT PROVIDE EDUCATIONAL
- 26 EXPERTISE AND RESOURCES RELATED TO THE HOLOCAUST, GENOCIDE AND
- 27 HUMAN RIGHTS VIOLATIONS TO DEVELOP THE CURRICULUM GUIDELINES.
- 28 THE GUIDELINES SHALL STATE THE MINIMUM AMOUNT OF INSTRUCTION
- 29 NECESSARY TO ADEQUATELY EDUCATE STUDENTS ON THE HOLOCAUST,
- 30 GENOCIDE AND HUMAN RIGHTS VIOLATIONS.

- 1 (C) BEGINNING WITH THE 2015-2016 SCHOOL YEAR, THE DEPARTMENT
- 2 OF EDUCATION SHALL MAKE AVAILABLE, TO ALL SCHOOL ENTITIES, IN-
- 3 SERVICE TRAINING PROGRAMS BASED UPON THE INSTRUCTION PROVIDED
- 4 FOR UNDER SUBSECTION (A) AND THE CURRICULUM GUIDELINES
- 5 ESTABLISHED PURSUANT TO SUBSECTION (B).
- 6 (D) (1) BEGINNING WITH THE 2015-2016 SCHOOL YEAR, EACH
- 7 SCHOOL ENTITY PROVIDING INSTRUCTION UNDER SUBSECTION (A) SHALL
- 8 PROVIDE, AS PART OF ITS IN-SERVICE TRAINING, PROGRAMS ON THE
- 9 HOLOCAUST, GENOCIDE AND HUMAN RIGHTS VIOLATIONS FOR ALL
- 10 INSTRUCTORS WHOSE TEACHING RESPONSIBILITIES INCLUDE COURSES OF
- 11 STUDY IN WHICH INSTRUCTION CONCERNING THE HOLOCAUST, GENOCIDE
- 12 AND HUMAN RIGHTS VIOLATIONS IS INTEGRATED. A SCHOOL ENTITY MAY
- 13 UTILIZE THE PROGRAMS MADE AVAILABLE BY THE DEPARTMENT OF
- 14 EDUCATION OR USE OTHER ALTERNATIVE PROGRAMS THAT ARE CONSISTENT
- 15 WITH THE PROVISIONS OF THIS SECTION.
- 16 (2) EMPLOYES REQUIRED TO COMPLETE CONTINUING PROFESSIONAL
- 17 EDUCATION UNDER SECTION 1205.2 SHALL RECEIVE CREDIT TOWARD THE
- 18 CONTINUING PROFESSIONAL EDUCATION REQUIREMENTS WHERE THE
- 19 TRAINING PROGRAM PROVIDED PURSUANT TO PARAGRAPH (1) HAS BEEN
- 20 APPROVED BY THE DEPARTMENT OF EDUCATION.
- 21 (E) THE DEPARTMENT OF EDUCATION SHALL PROVIDE THE
- 22 GUIDELINES, IN-SERVICE TRAINING AND ANY OTHER MATERIALS
- 23 DEVELOPED IN ACCORDANCE WITH THIS SECTION TO ANY NONPUBLIC
- 24 SCHOOL WITHIN THIS COMMONWEALTH UPON RECEIVING A REQUEST FROM
- 25 THE NONPUBLIC SCHOOL.
- 26 (F) THE STATE BOARD OF EDUCATION SHALL:
- 27 (1) CONDUCT A STUDY REGARDING THE MANNER IN WHICH
- 28 INSTRUCTION IN THE HOLOCAUST, GENOCIDE AND HUMAN RIGHTS
- 29 VIOLATIONS IS OFFERED BY SCHOOL ENTITIES IN THIS COMMONWEALTH.
- 30 IN CONDUCTING THE STUDY, THE STATE BOARD OF EDUCATION SHALL

- 1 REQUEST THAT EACH SCHOOL ENTITY PROVIDE THE STATE BOARD OF
- 2 EDUCATION WITH INFORMATION CONCERNING WHETHER THE SCHOOL ENTITY
- 3 OFFERS SUCH INSTRUCTION AND THE MANNER IN WHICH SUCH INSTRUCTION
- 4 IS OFFERED. EACH SCHOOL ENTITY SHALL PROVIDE INFORMATION TO THE
- 5 STATE BOARD OF EDUCATION IN RESPONSE TO A REQUEST UNDER THIS
- 6 PARAGRAPH. FOLLOWING THE 2016-2017 SCHOOL YEAR, BUT NOT LATER
- 7 THAN NOVEMBER 30, 2017, THE STATE BOARD OF EDUCATION SHALL ISSUE
- 8 A REPORT TO THE GOVERNOR, THE SECRETARY OF EDUCATION, THE
- 9 CHAIRMAN AND MINORITY CHAIRMAN OF THE EDUCATION COMMITTEE OF THE
- 10 SENATE AND THE CHAIRMAN AND MINORITY CHAIRMAN OF THE EDUCATION
- 11 COMMITTEE OF THE HOUSE OF REPRESENTATIVES ADDRESSING THE
- 12 FOLLOWING:

- 16 GUIDELINES ESTABLISHED BY THE DEPARTMENT OF EDUCATION UNDER
- 17 SUBSECTION (B).
- 18 (III) THE NUMBER OF SCHOOL ENTITIES USING THE IN-SERVICE
- 19 TRAINING PROGRAMS MADE AVAILABLE BY THE DEPARTMENT OF EDUCATION
- 20 UNDER SUBSECTION (C).
- 21 (IV) A DESCRIPTION OF THE MANNER IN WHICH SCHOOL ENTITIES
- 22 ARE OFFERING INSTRUCTION IN THE HOLOCAUST, GENOCIDE AND HUMAN
- 23 RIGHTS VIOLATIONS, INCLUDING THE NUMBER OF HOURS OF INSTRUCTION
- 24 OFFERED, THE GRADE LEVELS AT WHICH SUCH INSTRUCTION IS OFFERED
- 25 AND THE COURSE WITHIN SUCH INSTRUCTION IS INTEGRATED.
- 26 (V) THE RECOMMENDATIONS FOR IMPROVEMENTS TO THE OFFERING OF
- 27 INSTRUCTION IN THE HOLOCAUST, GENOCIDE AND HUMAN RIGHTS
- 28 VIOLATIONS, INCLUDING RECOMMENDED LEGISLATION.
- 29 (2) ADOPT A REGULATION, PURSUANT TO THE ACT OF JUNE 25, 1982
- 30 (P.L.633, NO.181), KNOWN AS THE "REGULATORY REVIEW ACT," TO

- 1 REQUIRE SCHOOL ENTITIES TO OFFER INSTRUCTION IN THE HOLOCAUST,
- 2 GENOCIDE AND HUMAN RIGHTS VIOLATIONS THAT IS CONSISTENT WITH
- 3 SUBSECTIONS (A) AND (B), IF THE STUDY CONDUCTED BY THE STATE
- 4 BOARD OF EDUCATION UNDER PARAGRAPH (1) DEMONSTRATES THAT LESS
- 5 THAN NINETY PERCENT OF THE SCHOOL ENTITIES ARE OFFERING
- 6 INSTRUCTION IN THE HOLOCAUST, GENOCIDE AND HUMAN RIGHTS
- 7 VIOLATIONS CONSISTENT WITH SUBSECTIONS (A) AND (B).
- 8 (3) ADOPT RULES AND REGULATIONS NECESSARY FOR THE
- 9 IMPLEMENTATION OF THIS SECTION PURSUANT TO THE "REGULATORY
- 10 REVIEW ACT."
- 11 (G) FOR PURPOSES OF THIS SECTION, THE TERM "SCHOOL ENTITY"
- 12 SHALL MEAN A SCHOOL DISTRICT, CHARTER SCHOOL, REGIONAL CHARTER
- 13 SCHOOL, CYBER CHARTER SCHOOL, INTERMEDIATE UNIT OR AREA CAREER
- 14 AND TECHNICAL SCHOOL.]
- 15 SECTION 2. THE ACT IS AMENDED BY ADDING A SECTION TO READ:
- 16 SECTION 1554.1 HOLOCAUST, GENOCIDE AND HUMAN RIGHTS
- 17 VIOLATIONS INSTRUCTION REQUIRED. -- (A) (1) BEGINNING WITH
- 18 <u>SCHOOL YEAR 2025-2026, A SCHOOL ENTITY SHALL OFFER INSTRUCTION</u>
- 19 IN THE HOLOCAUST, GENOCIDE AND HUMAN RIGHTS VIOLATIONS TO
- 20 STUDENTS. THE INSTRUCTION SHALL BE INTEGRATED WITHIN THE SOCIAL
- 21 STUDIES AND LANGUAGE ARTS COURSES OF STUDY REQUIRED IN

- 21 THE FACE OF GENOCIDE, INCLUDING THE HOLOCAUST AND ANY OTHER
- 22 GENOCIDE PERPETRATED AGAINST HUMANITY, INCLUDING THE RWANDAN
- 23 GENOCIDE AND OTHER GENOCIDES COMMITTED IN AFRICA, ASIA AND
- 24 EUROPE.
- 25 (III) HUMAN RIGHTS VIOLATIONS.
- 26 (IV) ANTI-SEMITISM, RACISM AND THE ABRIDGMENT OF CIVIL
- 27 RIGHTS.
- 28 (2) THE DEPARTMENT SHALL WORK IN CONSULTATION WITH
- 29 ORGANIZATIONS AND INDIVIDUALS THAT PROVIDE EDUCATIONAL EXPERTISE
- 30 AND RESOURCES RELATED TO THE HOLOCAUST, GENOCIDE AND HUMAN

- 1 RIGHTS VIOLATIONS TO REVIEW AND UPDATE EXISTING CURRICULUM
- 2 GUIDELINES AS NECESSARY. THE GUIDELINES SHALL STATE THE MINIMUM
- 3 AMOUNT OF INSTRUCTION NECESSARY TO ADEOUATELY EDUCATE STUDENTS
- 4 ON THE HOLOCAUST, GENOCIDE AND HUMAN RIGHTS VIOLATIONS. THE
- 5 GUIDELINES SHALL BE POSTED ON THE DEPARTMENT'S PUBLICLY
- 6 ACCESSIBLE INTERNET WEBSITE.
- 7 (C) BEGINNING WITH THE 2025-2026 SCHOOL YEAR, THE DEPARTMENT
- 8 SHALL MAKE AVAILABLE TO SCHOOL ENTITIES IN-SERVICE TRAINING
- 9 PROGRAMS BASED UPON THE INSTRUCTION PROVIDED FOR UNDER
- 10 SUBSECTION (A) AND THE CURRICULUM GUIDELINES ESTABLISHED
- 11 PURSUANT TO SUBSECTION (B).
- 12 (D) (1) BEGINNING WITH THE 2025-2026 SCHOOL YEAR, A SCHOOL
- 13 ENTITY PROVIDING INSTRUCTION UNDER SUBSECTION (A) SHALL PROVIDE
- 14 AS PART OF ITS IN-SERVICE TRAINING PROGRAMS ON THE HOLOCAUST,
- 15 GENOCIDE AND HUMAN RIGHTS VIOLATIONS FOR ALL INSTRUCTORS WHOSE

- 25 BY THE DEPARTMENT.
- 26 (E) THE DEPARTMENT SHALL PROVIDE THE GUIDELINES, IN-SERVICE
- 27 TRAINING AND ANY OTHER MATERIALS DEVELOPED IN ACCORDANCE WITH
- 28 THIS SECTION TO A NONPUBLIC SCHOOL WITHIN THIS COMMONWEALTH UPON
- 29 <u>RECEIVING A REQUEST FROM THE NONPUBLIC SCHOOL.</u>
- 30 (F) (1) BEGINNING WITH THE 2025-2026 SCHOOL YEAR AND EACH

- 1 SCHOOL YEAR THEREAFTER, A SCHOOL ENTITY SHALL POST ON THE SCHOOL
- 2 ENTITY'S PUBLICLY ACCESSIBLE INTERNET WEBSITE AN INTERNET LINK
- 3 OR TITLE FOR RESOURCES USED BY THE SCHOOL ENTITY FOR HOLOCAUST,
- 4 GENOCIDE AND HUMAN RIGHTS VIOLATIONS INSTRUCTION, A COURSE
- 5 SYLLABUS OR A WRITTEN SUMMARY OF THE HOLOCAUST, GENOCIDE AND
- 6 HUMAN RIGHTS VIOLATIONS CURRICULUM OFFERED BY THE SCHOOL ENTITY.
- 7 (2) THE CHIEF SCHOOL ADMINISTRATOR OR A DESIGNEE SHALL
- 8 IMPLEMENT THIS SUBSECTION.
- 9 (3) THIS SUBSECTION SHALL NOT BE CONSTRUED TO REQUIRE A
- 10 SCHOOL ENTITY TO VIOLATE THE COPYRIGHT, TRADEMARK OR OTHER
- 11 INTELLECTUAL PROPERTY RIGHT OF THE CREATOR OR OWNER OF THE
- 12 CURRICULUM.
- 13 (G) AS USED IN THIS SECTION, THE FOLLOWING WORDS AND PHRASES
- 14 SHALL HAVE THE MEANINGS GIVEN TO THEM IN THIS SUBSECTION UNLESS
- 15 THE CONTEXT CLEARLY INDICATES OTHERWISE:
- 16 "ANTI-SEMITISM." A CERTAIN PERCEPTION OF JEWS, WHICH MAY BE
- 17 EXPRESSED AS HATRED TOWARD JEWS, IN THE FORM OF RHETORICAL AND
- 18 PHYSICAL MANIFESTATIONS DIRECTED TOWARD JEWISH OR NON-JEWISH
- 19 INDIVIDUALS, THEIR PROPERTY, JEWISH COMMUNITY INSTITUTIONS OR
- 20 RELIGIOUS FACILITIES.
- 21 "DEPARTMENT." THE DEPARTMENT OF EDUCATION OF THE
- 22 COMMONWEALTH.
- 23 "GENOCIDE." THE TERM INCLUDES ANY OF THE FOLLOWING ACTS
- 24 COMMITTED WITH THE INTENT TO DESTROY, IN WHOLE OR IN PART, A
- 25 NATIONAL, ETHNIC, RACIAL OR RELIGIOUS GROUP:
- 26 <u>(1) KILLING MEMBERS OF THE GROUP.</u>
- 27 (2) CAUSING SERIOUS BODILY OR MENTAL HARM TO MEMBERS OF THE
- 28 GROUP.
- 29 (3) DELIBERATELY INFLICTING ON THE GROUP CONDITIONS OF LIFE
- 30 CALCULATED TO BRING ABOUT THE GROUP'S PHYSICAL DESTRUCTION, IN

- 1 WHOLE OR IN PART.
- 2 (4) IMPOSING MEASURES INTENDED TO PREVENT BIRTHS WITHIN THE
- 3 GROUP.
- 4 (5) FORCIBLY TRANSFERRING CHILDREN OF THE GROUP TO ANOTHER
- 5 GROUP.
- 6 "HOLOCAUST." THE SYSTEMATIC, STATE-SPONSORED PERSECUTION AND
- 7 ATTEMPTED ANNIHILATION OF JEWISH INDIVIDUALS AND OTHER GROUPS BY
- 8 THE NAZI REGIME IN GERMANY BETWEEN 1933 AND 1945, WHICH RESULTED
- 9 IN THE MURDER OF APPROXIMATELY SIX MILLION (6,000,000) JEWISH
- 10 INDIVIDUALS AND FIVE MILLION (5,000,000) OTHER INDIVIDUALS.
- 11 "SCHOOL ENTITY." A SCHOOL DISTRICT, CHARTER SCHOOL, REGIONAL
- 12 CHARTER SCHOOL, CYBER CHARTER SCHOOL, INTERMEDIATE UNIT OR AREA
- 13 CAREER AND TECHNICAL SCHOOL.
- 14 SECTION 3. THIS ACT SHALL TAKE EFFECT AS FOLLOWS:
- 15 (1) THE REPEAL OF SECTION 1554 OF THE ACT SHALL TAKE
- 16 EFFECT JUNE 30, 2025.
- 17 (2) THE REMAINDER OF THIS ACT SHALL TAKE EFFECT
