AN ACT

1 Amending Title 53 (Municipalities Generally) of the Pennsylvania
2 Consolidated Statutes, in public improvements, utilities and
3 services, providing for public notices, public meetings and
4 consent.

5 The General Assembly of the Commonwealth of Pennsylvania
6 hereby enacts as follows:

7 Section 1. Title 53 of the Pennsylvania Consolidated
8 Statutes is amended by adding a chapter to read:

4 § 5211. Definitions.

5 The following words and phrases when used in this subchapter
6 shall have the meanings given to them in this section unless the
7 context clearly indicates otherwise:

8 "Municipal corporation." A city, county, borough, township,
9 incorporated town, home rule municipality, optional plan
10 municipality or optional charter municipality.

11 "Public notice." Notice published once each week for two
12 successive weeks in a newspaper of general circulation and on
13 the municipal corporation's website, if the municipal
14 corporation has a publicly accessible Internet website.

15 § 5212. Sale or lease of water or sewer system.

16 In addition to the provisions of 65 Pa.C.S. Ch. 7 (relating
17 to open meetings), prior to entering into an agreement to sell
18 or lease a water or sewer system owned or operated by a
19 municipal corporation or to sell or lease a water or sewer
20 system currently owned or operated by a municipal authority that
21 would require dissolution by the municipal corporation, the
22 municipal corporation shall hold at least one advertised public
23 meeting, not more than 60 days nor fewer than seven days prior
24 to entering into the agreement with the potential purchaser or
25 lessee, and shall provide public notice of the meeting in all
26 municipalities served by the water or sewer system. The
27 potential purchaser or lessee shall attend the meeting.

28 § 5213. Requisite consent for acquisition of water or
29 wastewater companies.

30 An acquisition of an entity subject to section 5610(a.1)

1 (relating to governing body) under 66 Pa.C.S. § 1329 (relating
2 to valuation of acquired water and wastewater systems) may not
3 be deemed in the public interest by the Pennsylvania Public
4 Utility Commission without the unanimous consent of the
5 governing body established under section 5610(a.1).

6 Section 2. This act shall take effect in 60 days.
