- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 CHAPTER 1
- 7 PRELIMINARY PROVISIONS
- 8 Section 101. Short title.
- 9 This act shall be known and may be cited as the Patient
- 10 Comfort Act.
- 11 Section 102. Legislative intent.
- 12 The purpose of this act is to provide for education and
- 13 treatment of pain.
- 14 Section 103. Definitions.
- The following words and phrases when used in this act shall
- 16 have the meanings given to them in this section unless the
- 17 context clearly indicates otherwise:
- 18 "Department." The Department of Health of the Commonwealth.
- 19 "Health care facility." As defined in section 103 of the act
- 20 of July 19, 1979 (P.L.130, No.48), known as the Health Care
- 21 Facilities Act.
- 22 "HEALTH CARE PRACTITIONER." AS DEFINED IN SECTION 103 OF THE <--
- 23 ACT OF JULY 19, 1979 (P.L.130, NO.48), KNOWN AS THE HEALTH CARE
- 24 FACILITIES ACT.
- 25 "Health care provider." As defined in section 103 of the act
- 26 of July 19, 1979 (P.L.130, No. 48), known as the Health Care
- 27 Facilities Act.
- 28 "PALLIATIVE CARE." PATIENT AND FAMILY-CENTERED CARE THAT <--
- 29 OPTIMIZES QUALITY OF LIFE BY ANTICIPATING, PREVENTING AND
- 30 TREATING SUFFERING. PALLIATIVE CARE THROUGHOUT THE CONTINUUM OF

- 1 ILLNESS INVOLVES ADDRESSING PHYSICAL, INTELLECTUAL, EMOTIONAL,
- 2 SOCIAL AND SPIRITUAL NEEDS AND TO FACILITATE PATIENT AUTONOMY,
- 3 ACCESS TO INFORMATION AND CHOICE.
- 4 "Task force." The Pain Management and Palliative Care Task
- 5 Force established under Chapter 5.
- 6 CHAPTER 3
- 7 PATIENTS' BILL OF RIGHTS
- 8 Section 301. Rights.
- 9 Patients in health care facilities have the following rights:
- 10 (1) To be informed of all evidence-based options for
- 11 care and treatment, including palliative care, in order to
- 12 make a fully informed decision.
- 13 (2) When diagnosed with a terminal illness, to be
- informed by a clinician HEALTH CARE PRACTITIONER of all
- available options related to terminal care; to be able to
- request any, all or none of these options; and to expect and
- 17 receive supportive care for the specific option or options
- 18 available.
- 19 (3) To request or reject the use of any or all
- 20 treatments in order to relieve pain.
- 21 (4) To receive competent and compassionate medical
- assistance in managing physical and emotional symptoms.
- 23 (5) While suffering from a serious or life-limiting
- 24 illness or condition, to receive palliative care while
- seeking and undergoing potentially curative treatment.
- 26 (6) To receive a reasonable answer to any specific
- 27 question about a diagnosis, prognosis or foreseeable risks
- and benefits of a treatment option. A medical HEALTH CARE
- 29 practitioner shall not withhold any requested information
- 30 except to the extent that a reasonable medical HEALTH CARE

- 1 practitioner would withhold the information because the
- 2 manner and extent of such disclosure could reasonably be
- 3 expected to adversely and substantially affect the patient's
- 4 condition, in which case the medical HEALTH CARE practitioner <--
- 5 shall provide the information to a member of the patient's
- 6 immediate family.
- 7 (7) To know by name the medical HEALTH CARE practitioner <--
- 8 primarily responsible for coordinating care.
- 9 Section 302. Notification of rights.
- 10 The department shall notify all health care facilities and
- 11 health care providers in writing of the enactment of this
- 12 chapter. The notification shall contain the actual language of
- 13 the patients' bill of rights and any relevant quidance.
- 14 CHAPTER 5
- 15 EDUCATION AND TREATMENT
- 16 Section 501. Establishment of task force.
- 17 The Pain Management and Palliative Care Task Force is
- 18 established in the department.
- 19 Section 502. Composition of task force.
- The Secretary of Health or a designee shall serve as
- 21 chairperson of the task force. The members of the task force,
- 22 which the Secretary of Health shall be responsible for
- 23 appointing, shall be as follows:
- 24 (1) At least two of the members must be medical HEALTH <--
- 25 CARE practitioners specializing in pain management.
- 26 (2) At least two of the members must be medical HEALTH <--
- 27 CARE practitioners specializing in the care of the terminally
- 28 ill.
- 29 (3) At least one of the members must be a medical HEALTH <--
- 30 CARE practitioner specializing in pediatric palliative care.

- 1 (4) At least two of the members must be faculty members
- of a State-sponsored medical school.
- 3 (5) At least one of the members must be a representative <--
- 4 from the department.
- 5 Section 503. Meetings of task force.
- 6 The task force shall convene within 90 days after the
- 7 appointments are made and published and shall meet at the
- 8 discretion of the chairperson.
- 9 Section 504. Compensation and expenses of task force members.
- 10 The members of the task force shall receive no compensation
- 11 for their services but shall be allowed their actual and
- 12 necessary expenses incurred in performance of their duties. Such
- 13 reimbursement shall be provided through the department.
- 14 Section 505. Duties of task force.
- The task force shall have the following duties:
- 16 (1) To develop, using existing resources, a plan to
- 17 raise public awareness of the importance of pain management
- and palliative care and the patients' bill of rights.
- 19 (2) To facilitate coordination of and communication
- among State and local agencies and organizations to promote
- 21 palliative and pain management initiatives in this
- 22 Commonwealth.
- 23 (3) To research and develop a plan to ensure the
- 24 availability of concurrent care for pediatric patients facing
- 25 life-threatening illnesses.
- 26 (4) To research and develop a plan to ensure the
- 27 availability of palliative care in all hospitals in this
- 28 Commonwealth.
- 29 (5) To research and develop a plan which would ensure
- 30 that all State-supported medical schools have affiliations

- 1 with hospital palliative care programs.
- 2 Section 506. Report of task force.
- 3 On or before November 30, 2014, the task force shall present
- 4 a report to the chairman CHAIRPERSON of the Public Health and
- 5 Welfare Committee of the Senate and the chairman CHAIRPERSON of <--
- 6 the Health and Human Services Committee of the House of
- 7 Representatives. The report shall present findings on and
- 8 recommendations for the subjects assigned to the task force
- 9 under section 505.
- 10 CHAPTER 11
- 11 MISCELLANEOUS PROVISIONS
- 12 Section 1101. Effect on legal actions.
- Nothing in Chapter 3 or 5 creates a cause of action or
- 14 defense in favor of any person arising out of the failure to
- 15 comply with either of these chapters.
- 16 Section 1102. Effective date.
- 17 This act shall take effect in 60 days.
