A RESOLUTION

1 Designating May 8, 2021, as "National Association of Letter
2 Carriers Stamp Out Hunger Food Drive Day" in Pennsylvania and
3 commending the National Association of Letter Carriers for
4 its humanitarian efforts to eliminate hunger.

5 WHEREAS, On May 8, 2021, the National Association of Letter
6 Carriers (NALC) is conducting the 29th annual NALC "Stamp Out
7 Hunger" food drive to combat hunger; and

8 WHEREAS, The NALC's food drive is held in all 50 states and
9 territories of the United States and is the largest one-day food
10 drive in the nation; and

11 WHEREAS, On May 8, letter carriers are collecting
12 nonperishable donations as they deliver mail along their postal
13 routes; and

14 WHEREAS, The food is collected in more than 10,000
15 communities by letter carriers and other volunteers; and

16 WHEREAS, Donations are delivered to food banks, pantries and
17 shelters that serve the area where the donations are collected;
18 and

1 WHEREAS, The summer months are a particularly critical time
2 as donations and supplies are low and millions of children's
3 school lunch programs are suspended until fall, causing families
4 to find alternate sources of nutrition; and

5 WHEREAS, Letter carriers see families in need every day as
6 they deliver the mail, and this food drive is one way to help
7 alleviate their plight; and

8 WHEREAS, Postal patrons are encouraged to participate by
9 leaving donations by their mailboxes on May 8; and

10 WHEREAS, Cosponsors of this year's food drive include the
11 United States Postal Service, Valpak, Inc., AARP, the United
12 Food and Commercial Workers International Union, Valassis, Inc.,
13 local United Ways and the AFL-CIO; and

14 WHEREAS, Since the food drive's inception in 1993, local
15 letter carriers have collected more than 1.5 billion pounds of
16 food; therefore be it

17 RESOLVED, That the Senate designate May 8, 2021, as "National
18 Association of Letter Carriers Stamp Out Hunger Food Drive Day"
19 in Pennsylvania and commend the National Association of Letter
20 Carriers for its humanitarian efforts to eliminate hunger; and
21 be it further

22 RESOLVED, That the residents of this Commonwealth be
23 commended for their past participation in the NALC's food drive
24 and be encouraged to generously contribute to this year's effort
25 to help feed the hungry.
