It is enacted by the General Assembly as follows:

- 1 SECTION 1. Chapter 31-3 of the General Laws entitled "Registration of Vehicles" is
- 2 hereby amended by adding thereto the following section:
- 3 31-3-130. Registration plate to honor Governor Roger Williams. 4
 - (a) The administrator of the division of motor vehicles is empowered to make available a
- motor vehicle registration plate commemorating Governor Roger Williams as the first governor of 5
- 6 what became the State of Rhode Island. The plate shall bear the designation "Gov. Roger Williams"
- 7 and a design provided by the division, and shall bear the seal of the state imprinted on it. The plate
- 8 shall be displayed upon the same registration number assigned to the vehicle for which it was issued
- 9 and shall be used in place of and in the same manner as the original registration plates issued to the
- 10 vehicle. The original registration plates for the vehicle shall be removed from the vehicle and the
- 11 registration certificate for the plates shall be carried in the vehicle, in accordance with § 31-3-9.
- 12 The registration certificate shall be in effect for the plate.
- 13 (b) An automobile or commercial commemorative Governor Roger Williams plate shall be
- 14 issued upon application using forms furnished by the administrator upon payment in addition to the
- 15 regular prescribed motor vehicle registration fee.
- (c) In addition to the regular prescribed motor vehicle registration fee, the Governor Roger 16
- 17 Williams plates shall be subject to payment of a service charge of twenty-five dollars (\$25.00) and
- 18 a transfer charge of five dollars (\$5.00) for the plate, of which fifteen dollars (\$15.00) shall be
- deposited to the division of motor vehicles for its costs in manufacturing and distributing the plates, 19

- 1 and the remainder shall be deposited into the general fund.
- 2 SECTION 2. This act shall take effect upon passage.
