1	SECTION 1. Section 45-22-3 of the General Laws in Chapter 45-22 entitled "Loca"
2	Planning Board or Commission" is hereby amended to read as follows:

## 45-22-3. Membership -- Continuation of present membership.

4	(a) A planning board or commission consists of no less than five (5) members, and
5	appointments are made for terms of a length that the terms of no more than one third $(1/3)$ of the
6	members of the board or commission expire each year. Any vacancy occurring in the membership
7	of a planning board or commission shall be filled by the appointing authority for the remainder of
8	the unexpired term. Any member of a planning board or commission may be removed from office
9	by the appointing authority for due cause, following a public hearing.

10 (b) Vacancies to the planning board or commission occurring after May 4, 1972, shall be filled in the manner prescribed in this section, except as provided in § 45-22-1 in cities or towns 11 12 operating under a home rule charter.

# (c) The Hopkinton town council has the right to appoint two (2) alternate members to the

14 Hopkinton planning board and the Exeter town council may appoint two (2) alternate members to

- 15 the Exeter planning board and the Richmond town council has the right to appoint two (2)
- 16 alternate members to the Richmond planning board and the Barrington town council has the right

#### 17 to appoint two (2) alternate members to the Barrington planning board.

18 SECTION 2. Chapter 45-22 of the General Laws entitled "Local Planning Board or 19 Commission" is hereby amended by adding thereto the following section:

# 1 45-22-3.1. Planning boards' alternate members authorized.

- 2 The Hopkinton, Exeter, Richmond, Barrington, and Johnston town councils shall have
- 3 the right to appoint two (2) alternate members to their planning boards.
  - SECTION 3. This act shall take effect upon passage.
