RELATING TO EDUCATION - HEALTH AND SAFETY OF PUPILS

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 16-21-25 of the General Laws in Chapter 16-21 entitled "Health
2 and Safety of Pupils" is hereby amended to read as follows:

3 **16-21-25. Review of school safety plans - Waiver. --**

4 (a) Each city, town, or regional department school safety plan and school emergency
5 response plans shall be reviewed on an annual basis by the school committee and updated ~~as~~
6 ~~appropriate~~ annually. These reviews and updates shall be completed by November 1 of any given
7 year, and by December 31 of that year the commissioner of elementary and secondary education
8 shall report to the speaker of the house, the president of the senate, and the governor that such
9 reviews or updates have been completed.

10 (b) The commissioner of elementary and secondary education and school committee
11 shall make each city, town, or regional department school safety plan and school emergency
12 response plan available for public comment at least thirty (30) days prior to its adoption. All
13 meetings of school safety teams shall comply with the open meetings law pursuant to chapter 46
14 of title 42.

15 (c) The commissioner of elementary and secondary education may grant a waiver of the
16 requirements of §§ 16-21-23 and 16-21-24 to any city, town, or regional school department for
17 period of up to two (2) years upon a finding by the commissioner that the town, city, or regional
18 district had adopted a comprehensive school safety plan or school emergency response plans
19 which are in substantial compliance with the requirements of §§ 16-21-23 and 16-21-24.

1 Provided, however, no waiver shall extend beyond June 30, 2003.

2 SECTION 2. This act shall take effect upon passage.

EXPLANATION
BY THE LEGISLATIVE COUNCIL
OF

RELATING TO EDUCATION - HEALTH AND SAFETY OF PUPILS

1 This act would require school committees to annually review and update school safety
2 and school emergency plans by November 1 of each year. The act would further require that by
3 December 31 of each year, the commissioner of elementary and secondary education would
4 report to the general assembly and to the governor that such reviews and/or updates have been
5 completed. Such plans that are not deemed confidential pursuant to section 38-2-2 would be
6 available for public comment.

7 This act would take effect upon passage.
