# MAKING AN APPROPRIATION OF \$5,000,000 TO THE QUONSET DEVELOPMENT CORPORATION FOR WATERFRONT INFRASTRUCTURE IMPROVEMENTS

1 WHEREAS, Investment in infrastructure upgrades at the Port of Davisville plays a key 2 role in Rhode Island's future economic success as a leader in the growing "blue economy" and 3 offshore wind industry throughout the Northeast; and WHEREAS, The Port of Davisville supports nearly 1,700 jobs, \$98.9 million in 4 household earnings for Rhode Island families and \$374.3 million in business output annually. The 5 6 Port also generates \$45.5 million in total state tax revenue as well as \$10.5 million in local taxes; 7 and WHEREAS, In 2022, Rhode Island continued upgrades at Quonset's Port of Davisville 8 with the modernization of Pier 2 to accommodate larger vessels in order to continue to grow the 9 10 capacity for its auto import success and in preparation for future wind energy projects; and WHEREAS, Improvements in the waterfront infrastructure located on the west side of 11 12 the northeast corner extension of Davisville Pier 2 including, but not be limited to, pier 13 development and ancillary equipment to develop a dock, dock infrastructure and operate the pier, 14 including installation of battery clean charging infrastructure are essential to the continued 15 success and growth of this vital economic facility; now, therefore be it 16 RESOLVED, That there is hereby appropriated, out of any money in the treasury not 17 otherwise appropriated for the fiscal year 2023-2024, the sum of five million dollars (\$5,000,000)

to the Quonset Development Corporation for waterfront infrastructure improvements; and the

state controller is hereby authorized and directed to draw his orders upon the general treasurer for

1	the payment of said sum, or so much thereof as may be from time to time required, upon receipt
2	of properly authenticated vouchers.
