WHEREAS, "The future," in the wise words of Eleanor Roosevelt, "belongs to those who 1 2 believe in the beauty of their dreams." It was first a dream, but it soon became the mission of the School Department of the Town of North Smithfield to develop an approach that would inspire 3 4 middle school students to find the very best in themselves and to make the most of that discovery; 5 and 6 WHEREAS, North Smithfield Middle School's leaders and teachers decided that being 7 "run of the mill" was not where their students deserved to be; and 8 WHEREAS, The changes began in earnest with the opening of the brand new North Smithfield Middle School in the fall of 2008. The school is comprised of grades 6 through 8 and 9 in 2008 had an enrollment of 456 students; and 10 11 WHEREAS, "High expectations" became much more than a catch phrase. It became the 12 life force behind every action at North Smithfield Middle School and ignited a spark that has now 13 shone a spotlight on the incredible success that the elevated philosophy produced; and 14 WHEREAS, In one year's time, the school's test scores soared 20 percentage points in 15 reading, the largest improvement in the state, and more than 9 percentage points in math, placing 16 the school in the top quarter of Rhode Island's middle schools in that subject; and 17 WHEREAS, Led by Principal John Lahar, Assistant-Principal Clare Arnold, and backed wholeheartedly by a staff of forty dedicated teachers, the students at North Smithfield Middle 18

School, who were challenged by rigorous academic challenges on every level and in every

1 course, made strides and accomplished goals that by all standards are truly remarkable; now,

2 therefore be it

3 RESOLVED, That this House of Representatives of the State of Rhode Island and

4 Providence Plantations hereby recognizes and congratulates the students, teachers, support staff,

and administrators of North Smithfield Middle School who achieved successes that very few

people would have even dared to imagine as they demonstrated what "high expectations" can

achieve. We furthermore wish them continued success in reshaping the educational experience
