It is enacted by the General Assembly as follows:

- SECTION 1. The Town of West Warwick is hereby authorized and empowered to issue 1
- 2 bonds to an amount not exceeding six million four hundred thousand dollars (\$6,400,000), from
- 3 time to time under its corporate name and seal, pursuant to an ordinance to be adopted by the
- Town in accordance with the West Warwick Home Rule Charter and Rhode Island General Laws 4
- 5 §45-12-2.
- SECTION 2. In accordance with §16-7-44 of the general laws, the principal of and 6
- 7 interest on such bonds shall be eligible for state housing aid reimbursement.
- SECTION 3. This project, which was approved by the Commissioner of Elementary and 8
- 9 Secondary Education on or about March 22, 2007, shall be and remain eligible for school housing
- 10 aid.
