RELATING TO ALCOHOLIC BEVERAGES - IDENTIFICATION CARDS - EXPANSION OF  
ISSUANCE

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 3-8-6.1 of the General Laws in Chapter 3-8 entitled "Regulation of  
2 Sales" is hereby amended to read as follows:

3 ~~3-8-6.1. Identification cards for persons under the age of 21. ---~~ **Identification cards**  
4 **for persons without operator's licenses.** -- (a) (1) The administrator of the division of motor  
5 vehicles shall issue to any person upon request, ~~who is under twenty one (21) years of age,~~ an  
6 identification card upon payment of a fee of fifteen dollars (\$15.00), and, upon presentation of a  
7 certified birth or baptismal certificate, or U.S. or foreign passport, or U.S. naturalization  
8 certificate, or a valid immigrant or refugee document issued by the United States immigration and  
9 naturalization service including, but not limited to, any one of the following: Form I-551, Form I-  
10 94, Form I-688A, and Form I-688, or a valid federal tax identification number, together with a  
11 document bearing the applicant's signature. No person who holds an operator's license, issued by  
12 this state or any other state, shall be issued an identification card.

13 (2) The identification card shall be subject to renewal every five (5) years upon the  
14 payment of a fee of fifteen dollars (\$15.00).

15 (3) The identification card shall be signed by the administrator of the division of motor  
16 vehicles and also by the applicant, and his or her picture shall appear on the card along with the  
17 required information and the card shall be encased in laminated plastic. The card shall be two  
18 inches (2") in height and four inches (4") in length and shall be printed in the following form:

13 (4) The identification cards shall be produced at the adult correctional institution if they  
14 have facilities to do so; if the adult correctional institutions have no facilities to do so, then all  
15 cards shall be manufactured by the lowest responsible bidder following advertisement for the  
16 solicitation of bids.

17 (5) The identification cards shall be clearly distinguishable from those issued pursuant to  
18 section 3-8-6 and operators' and chauffeurs' licenses issued pursuant to title 31.

19 (b) The identification card may be withdrawn at any time for just cause, at the discretion  
20 of the administrator of the division of motor vehicles. The administrator of the division of motor  
21 vehicles shall keep a record of the cards issued and each card shall contain an identification  
22 number specifically assigned to the person to whom the card was issued.

23 SECTION 2. This act shall take effect upon passage.
