This bill specifies that no portion of an outdoor shooting range may be located within one hundred fifty yards of any portion of a residential neighborhood or school. The one hundred fifty-yard safety zone includes any potential stray or ricochet projectiles. The bill would potentially affect existing businesses and locations for new business and could impact zoning, business licenses, and other local government functions. In order to determine if this bill will impact local governments to implement the restrictions, Revenue and Fiscal Affairs contacted all counties and the Municipal Association of South Carolina. Six counties responded, including Aiken, Barnwell, Cherokee, Chesterfield, Dorchester, and Richland. The responding counties were not able to identify how many, if any, businesses would be affected. However, these counties indicated that the bill is not expected to impact expenditures or revenues. The impact on other counties may vary and is undetermined.

Two counties acknowledged concerns about implementation and enforcement based on the definitions and requirements of the bill but did not expect those issues to have a fiscal impact. The impact on other counties that did not respond may vary and is undetermined.
