<b>L1</b>	<u>(1)</u>	Prohibit, regulate, or curtail the otherwise lawful possession, carrying, sale,
L2		transportation, transfer, defensive use, or other lawful use of any:
L3		(a) Firearm, including any component or accessory;
L4		(b) Ammunition, including any component or accessory;
L5		(c) Ammunition-reloading equipment and supplies; or
L6		(d) Personal weapons other than firearms;
L7	<u>(2)</u>	Seize, commandeer, or confiscate in any manner, any:
18		(a) Firearm, including any component or accessory;
L9		(b) Ammunition, including any component or accessory;
20		(c) Ammunition-reloading equipment and supplies; or
21		(d) Personal weapons other than firearms;
22	<u>(3)</u>	Suspend or revoke a permit to carry a concealed pistol issued pursuant to chapter
23		23-7, except as expressly authorized in that chapter;
24	<u>(4)</u>	Refuse to accept an application for a permit to carry a concealed pistol, provided

the application has been properly completed in accordance with chapter 23-7;

1	<u>(5)</u>	Close or limit the operating hours of any entity engaged in the lawful selling or
2		servicing of any firearm, including any component or accessory; ammunition,
3		including any component or accessory; ammunition-reloading equipment and
4		supplies; or personal weapons other than firearms, unless the closing or limitation
5		of hours applies equally to all forms of commerce within the jurisdiction;
6	<u>(6)</u>	Close or limit the operating hours of any indoor or outdoor shooting range; or
7	<u>(7)</u>	Place restrictions or quantity limitations on any entity regarding the lawful sale or
8		servicing of any:
9		(a) Firearm, including any component or accessory;
10		(b) Ammunition, including any component or accessory;
11		(c) Ammunition-reloading equipment and supplies; or
12		(d) Personal weapons other than firearms.
13		Nothing in this section precludes a law enforcement officer, who is acting in the
14	<u>lawful</u>	discharge of the officer's official duties and with or without a warrant, from
15	tempo	rarily disarming a lawfully detained person, if the officer reasonably believes that
16	doing	so is immediately necessary for the protection of the officer or another person.
17	<u>Unless</u>	s the officer takes the person into custody for engaging in criminal activity or for
18	obser\	vation, or unless the officer seizes the item as evidence pursuant to a criminal

Any person aggrieved by a violation of this section may file an action for damages, injunctive relief, or other appropriate redress in the circuit court having jurisdiction over the county in which the aggrieved person resides or in which the violation occurred.

investigation, the officer shall return any item seized to the person.
