FOR THE INTRODUCED BILL**

1 **An Act to ~~increase the~~make an appropriation for ~~construction design~~ costs related**
2 **to the health services center at Black Hills State University–Rapid City, and**
3 **to declare an emergency.**

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

5 **Section 1.** There is hereby appropriated from the general fund the sum of \$1,500,000 to the
6 Board of Regents to contract for design, architectural and engineering services of an addition
7 for the health sciences center at Black Hills State University-Rapid City, as authorized by the
8 Legislature in section 1 of chapter 198 of the 2022 Session Laws.

9 **Section 2.** Any amounts appropriated in this Act not lawfully expended or obligated shall
10 revert in accordance with the procedures prescribed in chapter 4-8.

11 **Section 3.** The Executive Director of the Board of Regents shall approve vouchers and the
12 state auditor draw warrants to pay expenditures authorized by this Act.

13 **Section 34.** Whereas, this Act is necessary for the support of the state government and its
14 existing public institutions, an emergency is hereby declared to exist, and this Act shall be in
15 full force and effect from and after its passage and approval.

17 ~~—The Board of Regents is hereby authorized to contract for the planning, site preparation,~~
18 ~~renovation, furnishing, equipping, and construction of an addition for a health sciences center~~
19 ~~at Black Hills State University–Rapid City, together with furnishings and equipment, including~~
20 ~~heating, air conditioning, plumbing, water, sewer, electric facilities, sidewalks, parking,~~
21 ~~landscaping, architectural and engineering services, and such other facilities, services or~~
22 ~~actions as may be required to accomplish the project authorized in this Act, for an estimated~~
23 ~~cost of \$15,114,644 \$20,114,644, subject to permitted adjustments pursuant to section 3 of~~

1 **Section 2.** ~~That section 2 of chapter 198 of the 2022 Session Laws be AMENDED:~~

2 ~~—There is hereby appropriated to the Board of Regents, for the purposes authorized in this~~
3 ~~Act, the sum of \$5,000,000 from the general fund; the sum of \$8,000,000 in federal fund~~
4 ~~expenditure authority from the American Rescue Plan Act (ARPA) Capital Projects Fund~~
5 ~~moneys; the sum of \$5,114,644 in other fund expenditure authority from those portions of~~
6 ~~the higher education facilities fund allocable to Black Hills State University and South Dakota~~
7 ~~State University; and the sum of \$2,000,000 in other fund expenditure authority from donated~~
8 ~~funds, together with any additional sums received pursuant to section 4 of this Act, and~~
9 ~~permitted adjustments pursuant to section 3 of this Act.~~
