## **Senate Bill 86**

## AMENDMENT 86B FOR THE INTRODUCED BILL

1	An Act to allow a municipality authorized to allow legal games of chance to issue
2	additional convention off-sale liquor licenses to hotel-motel convention
3	facilities.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
5	Section 1. That § 35-4-2 be AMENDED:
6	35-4-2. The classes of licenses, with the fee of each class, are as follows:
7	(1) Repealed by SL 2018, ch 223, § 13;
8	(2) Wholesalers of alcoholic beverages—five thousand dollars;
9	(3) Off-salenot less than three hundred dollars. The renewal fee for the license may not
10	exceed five hundred dollars;
11	(4) On-salenot less than one dollar for each person residing within the municipality as
12	measured by the last preceding federal census. The renewal fee for the license may not exceed
13	fifteen hundred dollars;
14	(5) Off-sale licenses issued to municipalities under local option-not less than two hundred
15	fifty dollars;
16	(6) On sale licenses issued outside municipalities not less than the amount the nearest
17	municipality to the applicant is charging for a like license. The renewal fee shall be the same
18	as is charged for a like license in the nearest municipality. If the municipality to which the
19	applicant is nearest holds an on-sale license, pursuant to § 35-3-13 and does not charge a
20	specified fee, then the fee shall be the minimum amount that could be charged as if the
21	municipality had not been authorized to obtain on-sale licenses pursuant to § 35-3-13. The

## Section 1. That § 35-4-11.11 be AMENDED:

**35-4-11.11.** In addition to the licenses provided by §§ 35-4-10, 35-4-11 and 35-4-11.2, any municipality that is authorized by chapter 42-7B to allow legal games of chance may issue up to five additional convention facility off-sale licenses to hotel-motel convention facilities and twelve additional convention facility on-sale licenses to hotel-motel convention facilities. A hotel-motel convention facility as used in this section is a facility that, in a bona fide manner, is used and kept open for the hosting of large groups of guests for compensation which has at least fifty rooms which are suitable lodging accommodations and convention facilities with seating for at least one hundred fifty persons. In a locally designated historical district, in a municipality that is authorized to conduct gaming by chapter 42-7B, any license created by this section shall be is available to buildings subject to rehabilitation and restored according to the U.S. Department of the Interior standards for historic preservation projects codified in 36 C.F.R. Part 67 as of January 1, 1994. Such a The rehabilitation project shall must have at least thirty rooms that are suitable lodging accommodations.
