# House Bill 1058

*Introduced by: The Committee on Commerce and Energy at the request of the Department of Labor and Regulation*

1 **An Act to modify agency reporting requirements on licensure, certification, job**  
 2 **placements, and the labor market.**

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 **Section 1. That § 13-1-60 be AMENDED:**

5 **13-1-60.** If any department, board, or commission of the state administers a  
 6 licensure or certification examination to any person who completed a degree program at  
 7 an institution under the control of the Board of Regents, the department, board, or  
 8 commission ~~shall annually~~ must report to the Board of Regents ~~and the Department of~~  
 9 ~~Labor and Regulation~~ the following:

- 10 (1) The number of persons who completed a degree program at each institution under  
 11 the control of the Board of Regents to whom the department, board, or commission  
 12 administered a licensure or certification examination during that year; and  
 13 (2) The number of persons in subdivision (1) who successfully passed the licensure or  
 14 certification examination, including any subparts of any licensure or certification  
 15 process.

16 **Section 2. That § 13-1-61 be AMENDED:**

17 **13-1-61.** If any department, board, or commission of the state administers a  
 18 licensure or certification examination to any person who completes a degree program or  
 19 a training program at a public technical college in the state, the department, board, or  
 20 commission ~~shall annually~~ must report to the Board of Technical Education ~~and the~~  
 21 ~~Department of Labor and Regulation~~ the following:

- 22 (1) The number of persons who completed a degree program or training program at  
 23 each public technical college in the state and to whom the department, board, or  
 24 commission administered a licensure or certification examination during that year;  
 25 and

- 1           (2)    The number of persons in subdivision (1) who successfully passed the licensure or  
2                    certification examination, including any subparts of any licensure or certification  
3                    process.

4    **Section 3. That § 13-1-63 be REPEALED:**

5                    ~~The Department of Labor and Regulation shall annually work with the Board of~~  
6                    ~~Regents to determine the job placement outcomes for those persons completing a degree~~  
7                    ~~program at an institution under the control of the Board of Regents. The department shall~~  
8                    ~~also annually work with the Board of Technical Education to determine the job placement~~  
9                    ~~outcomes for those persons completing a degree program or training program at a public~~  
10                   ~~technical college in the state.~~

11   **Section 4. That § 13-1-64 be REPEALED:**

12                   ~~The Department of Labor and Regulation shall compile the information received~~  
13                   ~~pursuant to § 13-1-63 and provide it to the Executive Board of the Legislative Research~~  
14                   ~~Council no later than November fifteenth of each year.~~

15   **Section 5. That § 60-6-23 be REPEALED:**

16                   ~~The department shall publish a bulletin in which shall be made public all possible~~  
17                   ~~information with regard to the state of the labor market, including reports of the~~  
18                   ~~businesses of the various public employment offices.~~
