- 8 Development Commission who shall advise the. The commission may appoint, advise, direct,
- 9 and supervise an executive director of the Wheat Utilization, Research and Market Development

- 12 38-10-12. The wheat commission shall may appoint a full-time executive director to carry
- out the provisions of this chapter. The executive director shall receive such compensation as

- 38-10-14. The wheat commission may establish an administrative office for the wheat
- 4 commission in the State of South Dakota at such place as may be suitable for the furtherance
- 5 of this chapter. The In the administration of this chapter, the wheat commission may:
- 6 (1) Expend the funds collected pursuant to this chapter;
- 7 (2) Appoint, discharge, fix compensation for and prescribe the duties of such personnel as it may deem necessary subject to Bureau of Human Resources guidelines;
- 9 (3) Lease, purchase, own, equip, maintain, operate, and dispose of equipment in the commission office;
- 11 (4) Accept donations of funds, property, services, and other assistance from public, 12 private, and other sources for the purpose of aiding and promoting the work and 13 objectives of the commission;
- 14 (5) Appoint an attorney who shall act for the commission when needed;
