SENATE BILL NO. 23

Introduced by: The Committee on State Affairs at the request of the Board of Regents

1 FOR AN ACT ENTITLED, An Act to revise certain provisions regarding the ownership and
2 management of the South Dakota Art Museum.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. That § 13-58-19 be amended to read as follows:

5 13-58-19. The South Dakota ~~Memorial Art Center Building~~ Art Museum is the property of
6 the State of South Dakota. The purpose of the ~~center is to:~~

7 ~~— (1) — House choice selections and museum is to house pieces of art, sculpture, etchings,~~
8 ~~and other important cultural items belonging to the State of South Dakota and South~~
9 ~~Dakota State University or selected by the South Dakota Federation of Women's~~
10 ~~Clubs which shall to serve as the an inspiration to all citizens of South Dakota;~~

11 ~~— (2) — Contain headquarters and offices of the South Dakota Federation of Women's Clubs~~
12 ~~and a memorial room to honor pioneers, selected by it, who have made significant~~
13 ~~contributions to the progress of this state; and~~

14 ~~— (3) — Contain space sufficient to provide educational opportunities for the university~~
15 ~~commensurate with the cost of maintaining and paying the operational expense of~~



1 such buildings as specified in ~~§ 13-58-24~~.

2 The Board of Regents has authority over the museum. In recognition of its fund raising on
3 behalf of the South Dakota Art Museum, the South Dakota Federation of Women's Clubs may
4 obtain authorization to locate its headquarters and offices within the museum. The Board of
5 Regents may establish a memorial room in the museum to honor pioneers who made significant
6 contributions to the progress of the state, and the South Dakota Federation of Women's Clubs
7 may select the individuals to be included in the memorial room.

8 South Dakota State University is responsible for and shall perform all the functions of the
9 South Dakota Art Museum including business operations, accession, de-accession of holdings,
10 and operation and maintenance expenses. South Dakota State University shall assure that the
11 facility is managed and arranged as not to interfere with the rights, privileges, and purposes
12 assured by this section to the South Dakota Federation of Women's Clubs.

13 Any grant or donation made to the South Dakota Art Museum after July 1, 2015, may be
14 accepted and administered by South Dakota State University.

15 Section 2. That § 13-58-24 be repealed.

16 ~~— 13-58-24. The State Board of Regents shall have full and complete authority over said~~
17 ~~building, subject to the right of the donor committee to make use thereof for their purposes as~~
18 ~~provided in subdivisions 13-58-19(1) and (2), and the use which the university is to make of~~
19 ~~such building shall be so arranged as not to interfere with the donor's rights, privileges, and~~
20 ~~purposes therein.~~

21 ~~— The said university, at its expense, shall furnish the maintenance and operation costs of said~~
22 ~~building from its facilities in exchange for the use thereof by the university as specified in § 13-~~
23 ~~58-19.~~
