WHEREAS, he continues to place flags at the Nashville Memorial Cemetery in Madison each Memorial Day and, since 2004, has placed the wreath at that cemetery's Memorial Day

services. In addition, he has played the trumpet for many patriotic and political events in his community, was a speaker at his community's annual Independence Day Celebration, played taps during Greenbrier's Memorial Day service, and was given a flag which had flown over the Marine Corps War Memorial in Washington, D.C.; and

WHEREAS, no stranger to awards and accolades, James Milam was recognized by the mayor of his community, who designated the month of July in James's honor, was given a resolution by the Sumner County Commission in recognition of his patriotism and his work on his Eagle project, and was named an honorary member of the United States Marines; and

WHEREAS, James's Eagle project greatly contributed to the betterment of his community and reflected the true spirit of Volunteerism; and

WHEREAS, it is appropriate that we should pause to recognize James Milan as one of the most outstanding young people in our State; now, therefore,
