WHEREAS, Dan Brooks has established a significant record of leadership and service on the local, state, and national levels throughout his career; his professional experiences reflect a diverse mixture of administration, teaching, and leadership, and his record of civic and public service involvement reflects commitment to his communities; and

WHEREAS, Mr. Brooks epitomizes the spirit and commitment that are characteristic of a true Tennessean; and
