WHEREAS, Marjie and Robert Mahar are active members of Temple Baptist Church in White House; Mrs. Mahar is also a proud member of the Daughters of the American Revolution General Jethro Sumner Chapter, which she current currently serves as chaplain; and

WHEREAS, Marjie Mahar is extremely proud of her rich heritage, which she traces back to the Revolutionary War; before, during, and after the Korean War, four of her five brothers served in the military, as well as her two brothers-in-law; and WHEREAS, one of her brothers, Private First Class Roland Bowser, gave the ultimate sacrifice, as he was captured in North Korea on November 2, 1950, and spent the remaining months of his young life as a prisoner of war, until his death in June 1951; and

WHEREAS, to honor his memory, Mrs. Mahar read a letter she had written to her deceased brother at the War Memorial in Seoul, South Korea, on Memorial Day in 2019; a copy of her letter, written in Korean, was placed on the chair of every guest, so that, as she read her letter aloud, the Korean War veterans and military members would be able to read it in their own language; and

WHEREAS, she believes one of her missions in life is to keep Roland's memory alive by sharing her family's story, sharing the poignant epic of family, love of God and country, sacrifice, and America's contribution to freedom throughout the world; and

WHEREAS, the success of Tennessee, the strength of our communities, and the overall vitality of our society depend, in great measure, on the dedication of people like Marjie Mahar, who use their considerable talents and resources to serve others; and

WHEREAS, we find it appropriate to acknowledge and applaud Mrs. Mahar for her many contributions to honoring service members and serving those in her community; and
