WHEREAS, he worked at both WDXB and WGOW, but his most notable work can be traced back to his time working at WGOW in the 1980s, where he and his partner Dale Deason hosted a morning show together. In recent years, he filled in at WGOW talk radio as a substitute when hosts were sick or on vacation; and

WHEREAS, he also worked in the healthcare field as a marketing assistant for Memorial Hospital. While working at Memorial, he started the water bottle program, which urged people to stay hydrated and drink water; and

WHEREAS, in the mid-1990s, he was a news anchor for WDEF-TV for two years; he also served as a spokesman for Hospice of Chattanooga and was a frequent guest on local TV news and talk programs; and

WHEREAS; a community-oriented individual, Mr. McGowan contributed to a number of local fundraisers, galas, cookie sales, and nonprofit organization projects; and

WHEREAS, Mr. McGowan was an active and devout member of Christ United Methodist Church in East Brainerd, which he served faithfully for many years as a board member; and WHEREAS, he was also deeply devoted to his family, and he always endeavored to remain true to family values of the highest order; and

WHEREAS, he is survived by his three wonderful children, Kellan (Kristin) McGowan,
Hunter McGowan, and Brittany (Mike) Kolodziej; his two grandchildren, Lucy Grace and Watson
James; and his aunt, Esther (Richard) Follis; and

WHEREAS, he was preceded in death by his parents, Betty McGowan and Charles McGowan, and trusty companion, Max the Dog; and

WHEREAS, Garry "Mac" McGowan leaves behind an indelible legacy of integrity and probity in public life, compassion and loyalty in private life, and diligence and dedication in all his chosen endeavors; and
