WHEREAS, since 90 percent of cardiac arrests happen outside the hospital and are most likely to occur at home or at work, Dr. Brown's educational services are invaluable tools that prevent tragedy in emergencies; she is a living witness to the effectiveness of CPR, as she saved her own life through its use; and

WHEREAS, Dr. Brown is a consummate professional, dedicated public servant, and reliable friend and neighbor; and

WHEREAS, Dr. Katherine Y. Brown is wholly committed to the noble precepts of public service that have earned Tennessee recognition as the Volunteer State, and she should be specially recognized; now, therefore,
