WHEREAS, Ruth Huddleston was an exemplary and conscientious public servant and consummate professional who worked assiduously to improve the quality of life for her fellow citizens; and

WHEREAS, born on September 8, 1925, in Windrock, Mrs. Huddleston was the daughter of William David and Beulah White Sisson and a lifelong resident of the Coalfield and Oliver Springs area; and

WHEREAS, Mrs. Huddleston went on to earn her Bachelor of Science degree in Education and Master of Arts degree in Guidance and Counseling from the University of Tennessee; she taught two summers at Knoxville College, in addition to teaching high school and elementary school in Coalfield and one year in Windrock in the mining camp; and

WHEREAS, during her incredible thirty-six-year tenure in education, she served as Beta Club sponsor for thirty years; she also served as guidance counselor at Coalfield High School and Oliver Springs High School; and

WHEREAS, after retirement, Ruth Huddleston worked as a leader in Weight Watchers in Harriman and Kingston; she enjoyed writing letters and cards to others, especially her fellow congregants at Central Baptist Church in Oak Ridge; and

WHEREAS, she was also wholly devoted to her family and always endeavored to remain true to family values of the highest order; and

WHEREAS, left to mourn her memory are her children, Lanny (Carla) Huddleston, Lois Huddleston, and Karen (Dean) Mayes; grandchildren, Misty (Neil) Hasty, Sunshine (Curtis) Narramore, Hope (Tyler) Saunders, Katharine (Matt) LeCraw, Loren (Jessica) Huddleston, and Erika Edmonds; and eleven great-grandchildren, including Luke and Belle, who helped take care of her in the final months of her life; and
