WHEREAS, Rebecca S. Sharber is one such estimable person, who has served with distinction approximately twenty years as director of two Tennessee public school systems; and

WHEREAS, Rebecca Sharber will be taking a much-deserved retirement on June 30, 2015, from Franklin County Public Schools, where she has served as director since April 2009; and

WHEREAS, she received her bachelor's degree in education from Henderson State
University in Arkadelphia, Arkansas, in 1972; her master's degree in educational administration

She served as principal of Bethesda Elementary School from July 2001 to July 2004, and for a time served as executive administrative assistant to the commissioner of the Tennessee Department of Education; and

WHEREAS, in each leadership position, Director Sharber managed daily operations of dynamic and rapidly growing public school systems, and she successfully established and maintained positive environments for teaching and learning; and

WHEREAS, Mrs. Sharber is an active and important part of her community and her profession, participating in numerous worthy organizations, including holding leadership in the Tennessee Organization of School Superintendents, and membership in the Williamson County/Franklin Chamber of Commerce, Williamson County United Way, Franklin Noon Rotary Club, Tennessee Basic Education Program Review Committee, the 1997 Class of the Tennessee Government Executive Institute, 1995 Class of Leadership Brentwood, and Girl Scouts and Boy Scouts board of directors, and for a time, she represented District Twelve on the Williamson County Commission; and

WHEREAS, Rebecca Sharber has been recognized for her expertise, having been named as one among the Williamson 25 for being a most influential citizen in 2005, recipient of the 1995 AARP National Women's History Month Award, Lions Club Educator of the Year in 1992, Toastmasters' Communicator of the Year in 1992, and Williamson County Education Association's "Friend of Teachers" in 1989; and

WHEREAS, Mrs. Sharber is the wife of Jerry Sharber and the mother and stepmother of Jim Schwab, Spencer Schwab, Philip Schwab, Joseph Schwab, Renee Spiker, Wendy Sharber, Christy Gross, and Beth Sharber; and

WHEREAS, Rebecca Sharber exemplifies the spirit and allegiance to family and community that are characteristic of a true Tennessean; and

WHEREAS, throughout her estimable career, Mrs. Sharber has demonstrated the utmost professionalism, ability, and integrity, winning the unbridled respect and admiration of her colleagues and the community as a whole; now, therefore,

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED NINTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE SENATE CONCURRING, that we hereby recognize and congratulate Rebecca S.
