WHEREAS, a distinguished drill coach, Sergeant First Class (Retired) Duncan led the Drill Team to the All Army Nationals for ten consecutive years, and the Exhibition Drill Team received first place honors at the 7th Brigade Drill Meet two consecutive years; and
