store, all of which have been managed by A.J. Mitchum; Webb Mitchum's father, Carlisle Mitchum; Webb Mitchum himself; and Webb Mitchum's son, Mitch Mitchum, all of whom were or are pharmacists; and

WHEREAS, Webb Mitchum has been essential to the continuous operation of Mitchum Drug Company and has worked alongside his immediate family members, including his sister, Margaret Ruth Simpson, also a pharmacist, and other extended family members and many loyal and dedicated employees, all of whom provided the very best healthcare and quality service to customers in Houston County and the Middle Tennessee region; and

WHEREAS, Mr. Mitchum has also been actively engaged in the civic affairs of the City of Erin and dutifully served his community as a member of the Erin City Council for many years; and
