WHEREAS, Mr. Causey has served as the Associate Pastor for Worship and Music at Forest Hills Baptist Church since 1994, where he has developed and led children, youth, and adult choirs, and taken the Forest Hills Sanctuary Choir to Europe on choral mission trips numerous times, singing in major cities throughout Ukraine, Poland, and Italy; and

WHEREAS, Mr. Causey is an experienced choral clinician and adjudicator for numerous choral festivals and music camps with the Florida, Alabama, Georgia, Virginia, Tennessee, Kentucky, and Mississippi Baptist State Conventions; and

WHEREAS, in 2021, he was awarded the Paul B. Clark Church Music Award for outstanding contributions to ministry through music by the Tennessee Baptist Church Music Conference; and

WHEREAS, Mr. Causey is a member of the Tennessee Baptist Men's Chorale, serving in various leadership positions, and he participates in the American Choral Directors

Association, Chorister's Guild, Music Educator's National Conference, Tennessee Music Education Association, Tennessee Baptist Church Music Conference, and Baptist Church Music Conference; and

WHEREAS, Wayne Causey and his wife, Carrie, have been outstanding ministers, friends, and supporters for thousands of neighbors, colleagues, families, and friends with far-reaching impact; and
