WHEREAS, Major Chance has always sought out positions of greater responsibility and impact throughout his career and thus held other positions previous to his attainment of operations officer, including medic, medical operations officer, and survey section leader; and

WHEREAS, after more than thirty-six years of long and faithful service in the United States Army, Major Chance is taking his much-deserved retirement from military service on January 31, 2022; and

WHEREAS, throughout his illustrious tenure with the Tennessee National Guard, Major Chance has set a standard for effective leadership and personal excellence that we would all do well to emulate; now, therefore,
