WHEREAS, he enjoyed the loving companionship of his beloved wife, Cheryl Smith; and WHEREAS, in addition to his wife, he is survived by his children, Carla (Mark) Grace, Billy (Brittany) Smith, Jr., Jason (Star) Bilbrey, and Anthony (Jane) Smith; twelve grandchildren;
