WHEREAS, a man of principle and integrity, Dale Carr has proven that citizens can make a difference by being involved in their community, which principle he has demonstrated through his service as a founding member and the first treasurer of the Boys & Girls Club of the Smoky Mountains and a member of the Sevier County High School Alumni Association and Sevierville Downtown Association; and

WHEREAS, a realtor and auctioneer by profession, he has worked with the Robert F. Thomas Foundation to support the healthcare needs of Sevier County; and

WHEREAS, a graduate of Sevier County High School, Leadership Sevier, and TVA Accounting School, Representative Carr received his Certified Internal Auditor accreditation from Indiana University; and

WHEREAS, his many personal and professional accomplishments aside, Dale Carr is most appreciative of the love and companionship he shares with his wife, JoAnn; son and daughter-in-law, Brandon and Jamie Carr; and granddaughter, Finley Grace; and

WHEREAS, Representative Carr is committed to the precepts of public service that have earned Tennessee recognition as the Volunteer State, and he should be recognized upon his tenure in the General Assembly; now, therefore,
