WHEREAS, he further served his community as a volunteer firefighter for the Town of Mountain City and the Trade Volunteer Fire Department; additionally, he played a key role in facilitating gun safety and active shooter classes and contributing to constable training; and

WHEREAS, Sheriff Tester was a revered member of the Taylorsville Masonic Lodge 243 F&AM, Scottish Rite Mason, and the Jericho Shrine Temple; and

WHEREAS, Sheriff Tester was also deeply devoted to his family, and he always endeavored to remain true to family values of the highest order; and WHEREAS, he is survived by his wife of thirty-five years, Brenda Tester; several siblings-in-law; and a number of nieces and nephews; and

WHEREAS, Sheriff Tester leaves behind an indelible legacy of integrity and probity in public life, compassion and loyalty in private life, and diligence and dedication in all his chosen endeavors; and

WHEREAS, it is fitting that the members of this General Assembly should pause to remember the bountiful life of this exceptional public servant and human being; now, therefore,
