

SENATE JOINT RESOLUTION 30

A RESOLUTION to honor and commend Liz Rogers, 2019 class of Nashville's Top 30 Under 30.

WHEREAS, it is fitting that the members of this General Assembly should salute those citizens who, through their extraordinary efforts, have distinguished themselves as community leaders of whom we can all be proud; and

WHEREAS, one such individual is Liz Rogers, who was recently recognized as a member of the 2019 class of Nashville's Top 30 Under 30, presented by the Tennessee chapter of the Cystic Fibrosis Foundation; and

WHEREAS, each year, the Tennessee chapter selects thirty individuals for Nashville's Top 30 Under 30, which recognizes business professionals throughout Middle Tennessee for their leadership qualities, volunteerism, and business endeavors; and

WHEREAS, Ms. Rogers is the founder, chief executive officer, and creative director of Anacrusis, a Nashville-based music publishing and licensing company that focuses on local alternative artist-writers; since founding the company in July 2014, she has worked closely with more than seventy-five artist-writers and cultivated relationships with over 400 music supervisors and publishers worldwide to secure music placements and help her clients thrive in the music industry; and

WHEREAS, Liz Rogers graduated with a Bachelor of Music degree in Voice and a minor in theatre from Vanderbilt University, where she appeared on the Dean's List six of her eight semesters, worked as an adjunct artist teacher, and earned a 3.64 cumulative grade point average; and

WHEREAS, deeply committed to the Nashville community, Ms. Rogers serves as a mentor with the Nashville Entrepreneur Center and a volunteer on the build team with Habitat

for Humanity; she helped launch the SOLID Mentorship Program and the Mentorship Program at the Cohn Learning Center, where she works with at-risk high school students who are not on track to graduate; and

WHEREAS, this General Assembly finds it appropriate to acknowledge and applaud the individuals of the 2019 class of Nashville's Top 30 Under 30 for their dedication to the State of Tennessee and its citizens; now, therefore,
