WHEREAS, in addition to his professional contributions, he gave much of his time and energy to various community organizations, serving as a member and deacon at New Providence Presbyterian Church; a board member of Blount County United Way, Blount County Vocational Training Center, Blount County Education Association, Maryville College Alumni Association, and Friends of the Blount County Library; an officer and longtime member of the Kiwanis Club of Alcoa; a member of the Knoxville Philatelic Society and Friends of the Great Smoky Mountains National Park; and a seasonal ranger in the Great Smoky Mountains National Park; and

WHEREAS, a dedicated family man, Stu McNiell was preceded in death by his beloved parents and his brother, Joseph Walter McNiell; and

WHEREAS, his memory will be forever cherished by his wife of fifty-six years, Sarah Brown McNiell; his son, Stuart P. McNiell III, and his wife, Anna; his daughter, Helen Anne McNiell, and her husband, Antonio Alcala; his grandchildren, Stuart P.
