A RESOLUTION to commend William Talley Ridley for exemplary service as a legislative intern.

WHEREAS, each legislative session this body is pleased to recognize certain persons who have committed themselves, through their adroit service, to the betterment of the legislative process; and

WHEREAS, William Talley Ridley is one such individual who has distinguished himself in his role as a legislative intern for Senator Diane Black, Senate Republican Caucus Chair; William's work has resulted in innumerable benefits for the legislators he assisted and the General Assembly as a whole; and

WHEREAS, born on April 5, 1988 to Becky and Gregg Ridley, William grew up on a 30-acre farm in Pikeville with his parents and his younger brother, Matt Ridley; and

WHEREAS, a 2006 graduate of Bledsoe County High School, Mr. Ridley stood as President of the Young Republican Organization and was a member of Future Farmers of America, the Beta Club, the 4-H Club, the First Priority Christian Club, and Family, Career, and Community Leaders of America, through which he competed in the Creed Speech Competition and won second place in the State; and

WHEREAS, a natural athlete, William Ridley was a valuable member of the basketball team for all four years of high school, during which time his remarkable skills earned him the honor of being named to several All-Tournament teams and winning the Best Free Throw Shooter Award in 2006; he also ran on the cross-country team for three years; and

WHEREAS, following his natural propensity for politics, he attended 4-H Congress, at which he acted as a Senator at the State Capitol for one week; it was during this week that William first found his deep interest in Tennessee Government; and

WHEREAS, during his junior year of high school, William shadowed Representative Eric Swafford for three days; and

WHEREAS, while shadowing, William had the honor of sitting on the House floor with Representative Swafford during session and voting "yes" for him on the resolution allowing a referendum to amend the State Constitution and define marriage as a union between one man and one woman; and

WHEREAS, upon his graduation from high school, William Ridley was selected from 125 students to receive the Citizenship Award from Bledsoe County High School; and

WHEREAS, since then, he has gained experience in a variety of jobs, working as a lifeguard during the summers of 2005 and 2006, serving as Assistant Pool Manager in 2007, and standing as Pool Manager in the summer of 2008, a job he plans to return to in the summer of 2009; and

WHEREAS, in addition to his employment with the pool, William has served as an employee in many part-time positions, including teaching swimming lessons through the American Red Cross, washing cars for Forrest Cate Ford, working at Fall Creek Falls State Park, and serving as a basketball referee for the non-profit Rebound Club Organization in Bledsoe County; and

WHEREAS, active on the campus of Middle Tennessee State University, he ran against twenty-five candidates during his freshman year and was elected as a Freshman Senator for the Student Government Association; also during his freshman year, he was elected President of his pledge class for the Sigma Phi Epsilon Fraternity and Vice President of Programming for the spring of 2007; and

WHEREAS, during the 2007-2008 academic year, William attended Tennessee

Technological University, where he made the Dean's List before returning to Middle Tennessee

State University for the fall of 2008; and

WHEREAS, recognized as a hardworking, politically astute student, William was selected to be a Legislative Intern for the 2009 session; and

WHEREAS, during his productive time with the General Assembly, Mr. Ridley was a member of the Intern Basketball team, which claimed victory over the State Legislators; he also participated in a mock election and mock session on the House floor; and
