WHEREAS, possessing exceptional grilling skills, Mr. Gaw thoroughly enjoyed grilling for his friends at the Cookeville Boat Dock; participating in cooking competitions with his barbeque team, "the Snoring Hogs," which included Brent Gentry and Tony Smith; and serving the community at the annual Lazy G stew cook; and WHEREAS, Little Eddie Gaw will be greatly missed by his family, friends, and neighbors and fondly remembered for "his infectious laugh, his ability to fix anything, and his love of serving others"; and
