1 **SECTION 1. APPOINTMENTS TO MILITARY SERVICE ACAD-**
2 **EMIES FROM NOMINATIONS MADE BY THE**
3 **RESIDENT COMMISSIONER FROM PUERTO**

5 (a) UNITED STATES MILITARY ACADEMY.—Para-
6 graph (7) of section 4342(a) of title 10, United States
7 Code, is amended—

8 (1) by striking “Six” and inserting “Sixteen”;

9 and

10 (2) by striking “five” and inserting “fifteen”.

11 (b) UNITED STATES NAVAL ACADEMY.—Paragraph
12 (7) of section 6954(a) of title 10, United States Code, is
13 amended—

14 (1) by striking “Six” and inserting “Sixteen”;

15 and

16 (2) by striking “five” and inserting “fifteen”.

17 (c) UNITED STATES AIR FORCE ACADEMY.—Para-
18 graph (7) of section 9342(a) of title 10, United States
19 Code, is amended—

20 (1) by striking “Six” and inserting “Sixteen”;

21 and

22 (2) by striking “five” and inserting “fifteen”.

23 (d) EFFECTIVE DATE.—The amendments made by
24 this section shall apply with respect to the nomination of
25 candidates for appointment to the United States Military
26 Academy, the United States Naval Academy, and the

1 United States Air Force Academy for classes entering
2 these military service academies after the date of the en-
3 actment of this Act.
