which was referred to the Committee on the Judiciary

## A BILL

To establish the Federal Interagency Task Force on  
Preventing Political Violence.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Preventing Political  
5       Violence Act”.

6       **SEC. 2. ESTABLISHMENT OF FEDERAL INTERAGENCY TASK**

7                   **FORCE ON PREVENTING POLITICAL VIO-**  
8                   **LENCE.**

9       (a) ESTABLISHMENT.—Not later than 180 days after  
10      the date of the enactment of this Act, the President shall

1 establish in the executive branch the Federal Interagency  
2 Task Force on Preventing Political Violence (in this Act  
3 referred to as the “Task Force”).

4 (b) MEMBERSHIP.—Not later than 180 days after the  
5 date of the enactment of this Act, the Task Force shall  
6 be composed of at least 24 members appointed as follows:

7 (1) The President shall appoint not less than  
8 three Task Force Staff, of which—

9 (A) one member shall be chosen from  
10 among the officials on the Domestic Policy  
11 Council of the White House; and

12 (B) one member shall be chosen from  
13 among the officials on the National Security  
14 Council of the White House.

15 (2) The head of each involved agency shall ap-  
16 point one official from such involved agency to serve  
17 on detail to the Task Force.

18 (c) TERMS.—Each member shall serve on the Task  
19 Force until the date on which the Task Force terminates  
20 under subsection (i).

21 (d) VACANCY.—In the case of a vacancy on the Task  
22 Force, such vacancy shall be filled not later than 30 days  
23 after arising and in the manner in which the original ap-  
24 pointment was made.

25 (e) STRUCTURE AND SUPPORT.—

1                     (1) TASK FORCE STAFF.—The Task Force  
2 Staff shall lead the daily operations of the Task  
3 Force, execute the duties described in subsection (g),  
4 and draft the text of each report under subsection  
5 (h).

6                     (2) INVOLVED AGENCY OFFICIALS.—The in-  
7 volved agency officials shall work together to deter-  
8 mine—

9                         (A) how the Task Force Staff shall execute  
10 the duties described in subsection (g); and  
11                         (B) the required content of each report  
12 submitted under subsection (h).

13                     (3) ADDITIONAL SUPPORT PERSONNEL.—The  
14 Task Force may appoint additional support per-  
15 sonnel as it considers appropriate.

16 (f) COMPENSATION.—

17                     (1) TASK FORCE STAFF.—The President shall  
18 fix the compensation for the Task Force Staff.

19                     (2) INVOLVED AGENCY OFFICIALS.—The in-  
20 volved agency officials shall not receive additional  
21 compensation for serving on detail to the Task  
22 Force.

23                     (3) ADDITIONAL PERSONNEL.—The Task Force  
24 shall fix the compensation for additional personnel  
25 appointed under subsection (e)(3).

1                 (g) DUTIES.—The duties of the Task Force are to—

2                         (1) advise and assist the President and the  
3                         head of each involved agency in the development  
4                         of—

5                                 (A) policy and programming recommenda-  
6                         tions for each involved agency, including inter-  
7                         agency or public-private partnerships, to en-  
8                         hance national unity and both prevent and re-  
9                         spond to political and hate-motivated violence  
10                         based on—

11                                 (i) the resources of each involved  
12                         agency available on the date of enactment  
13                         of this Act;

14                                 (ii) related programs under the ad-  
15                         ministrative jurisdiction of the involved  
16                         agencies that can be expanded upon; and

17                                 (iii) related authorities available to  
18                         each of the involved agencies to establish  
19                         new programs;

20                                 (B) the annual budget justification mate-  
21                         rials of each involved agency that are submitted  
22                         in conjunction with the budget of the United  
23                         States Government submitted to Congress  
24                         under section 1105(a) of title 31, United States  
25                         Code, to the extent that such materials relate to

1                   funding the recommendations made by the Task  
2                   Force pursuant to this Act; and

3                   (C) each report required under subsection  
4                   (h);

5                   (2) advise the President and the head of each  
6                   involved agency on specific program and policy mat-  
7                   ters related to the recommendations of the Task  
8                   Force, including providing subject matter expertise;

9                   (3) address and provide guidance to the Presi-  
10                  dent and the head of each involved agency on issues  
11                  related to national unity, civic-bridge building, and  
12                  political and hate-motivated violence prevention in  
13                  the United States;

14                  (4) consult with the Office of Public Engage-  
15                  ment of the White House to support the mission of  
16                  the Task Force;

17                  (5) consult with civil society organizations, as  
18                  well as other groups and individuals that are in-  
19                  volved in national unity and political and hate-moti-  
20                  vated violence prevention work, to identify potential  
21                  engagement opportunities for the Task Force, in-  
22                  cluding by holding hearings on such engagement op-  
23                  portunities; and

1                         (6) coordinate with the President and the head  
2                         of each involved agency on the duties of the Task  
3                         Force under this subsection.

4                         (h) REPORTS.—

5                         (1) INTERIM REPORTS.—Beginning on the date  
6                         that is six months after the Task Force is estab-  
7                         lished under subsection (a), and every six months  
8                         thereafter, the Task Force shall submit an interim  
9                         report to the President and the Congress and pub-  
10                         lish such report on the internet website of the White  
11                         House for the public as follows:

12                         (A) INITIAL INTERIM REPORT.—The initial  
13                         interim report shall contain a detailed state-  
14                         ment on the activities undertaken and rec-  
15                         ommendations made by the Task Force, pursu-  
16                         ant to the duties of the Task Force described  
17                         in subsection (g), since the establishment of the  
18                         Task Force.

19                         (B) SUBSEQUENT INTERIM REPORTS.—  
20                         Subsequent interim reports shall contain a de-  
21                         tailed statement on the activities undertaken  
22                         and recommendations made by the Task Force,  
23                         pursuant to the duties of the Task Force de-  
24                         scribed in subsection (g), since the most recent  
25                         previous interim report was submitted.

1                             (2) FINAL REPORT.—Not later than two years  
2 after the date on which the Task Force is estab-  
3 lished under subsection (a), the Task Force shall  
4 submit a final report to the President and the Con-  
5 gress and publish such report on the internet  
6 website of the White House for the public, con-  
7 taining the following:

8                             (A) The findings and conclusions of the  
9 Task Force.

10                            (B) The progress the President and each  
11 involved agency has made on implementing the  
12 recommendations made by the Task Force in  
13 each interim report the Task Force may choose  
14 to submit under paragraph (1).

15                            (C) Activities undertaken by the Task  
16 Force pursuant to the duties of the Task Force  
17 described in subsection (g).

18                            (D) A description of each program under  
19 the administrative jurisdiction of each involved  
20 agency that enhances national unity and helps  
21 prevent and respond to political and hate-moti-  
22 vated violence.

23                            (E) Recommendations for legislation and  
24 administrative action the Task Force considers  
25 appropriate.

1       (i) TERMINATION.—The Task Force shall terminate  
2 on the date that is two years after the date on which the  
3 Task Force is established under subsection (a).

4       (j) FEDERAL ADVISORY COMMITTEE ACT.—The  
5 Task Force shall be exempt from chapter 10 of title 5,  
6 United States Code (commonly known as the “Federal Ad-  
7 visory Committee Act”).

8       (k) DEFINITIONS.—In this Act:

9               (1) INVOLVED AGENCY.—The term “involved  
10 agency” means the following:

11                       (A) The Office of Management and Budg-  
12 et.

13                       (B) The Department of Labor.

14                       (C) The Department of Health and  
15 Human Services.

16                       (D) The Department of Agriculture.

17                       (E) The Department of Justice.

18                       (F) The Department of Housing and  
19 Urban Development.

20                       (G) The Department of Education.

21                       (H) The Department of Veterans Affairs.

22                       (I) The Department of Defense.

23                       (J) The Department of the Interior.

24                       (K) The Department of Commerce.

1                         (L) The Corporation for National and  
2                         Community Service.

3                         (M) The National Endowment for the  
4                         Arts.

5                         (N) The National Endowment for the Hu-  
6                         manities.

7                         (O) The Office of the Surgeon General.

8                         (P) The Small Business Administration.

9                         (Q) The Election Assistance Commission.

10                         (R) The Department of State.

11                         (S) The Department of Homeland Secu-  
12                         rity.

13                         (T) The Federal Emergency Management  
14                         Agency.

15                         (U) The Federal Bureau of Investigation.

16                         (2) INVOLVED AGENCY OFFICIAL.—The term  
17                         “involved agency official” means an individual ap-  
18                         pointed under subsection (b)(2).

19                         (3) TASK FORCE STAFF.—The term “Task  
20                         Force Staff” means an individual—

21                         (A) who is not an officer or employee of  
22                         any Federal, State, or foreign government and  
23                         who is specially qualified to serve on the Task  
24                         Force by virtue of their education, training, or

- 2       lence prevention work; and
- 3       (B) appointed under subsection (b)(1).
