A BILL

To establish youth advisory councils for the purpose of providing recommendations to the Environmental Protection Agency, Department of the Interior, Department of Energy, Department of Agriculture, and Department of Commerce with respect to environmental issues as those issues relate to youth communities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Youth Climate Leader-
3 ship Act of 2024”.

4 **SEC. 2. DEFINITIONS.**

5 In this Act:

6 (1) **COVERED AGENCY HEAD.**—The term “cov-
7 ered agency head” means each of the following
8 heads of agencies:

9 (A) The Administrator of the Environ-
10 mental Protection Agency.

11 (B) The Secretary of the Interior.

12 (C) The Secretary of Energy.

13 (D) The Secretary of Agriculture.

14 (E) The Secretary of Commerce.

15 (2) **DESIGNATED FEDERAL OFFICER.**—The
16 term “designated Federal officer” means the des-
17 ignated Federal officer for a Youth Advisory Council
18 appointed under section 3(b)(6).

19 (3) **DISADVANTAGED COMMUNITY.**—The term
20 “disadvantaged community” means a community
21 identified as a disadvantaged community by the
22 Justice40 Initiative (or a successor initiative) and
23 the Climate and Economic Justice Screening Tool of
24 the Council on Environmental Quality (or a suc-
25 cessor tool).

1 (4) ENVIRONMENTAL JUSTICE.—The term “en-
2 vironmental justice” means the just treatment and
3 meaningful involvement of all people, without regard
4 to income, race, color, national origin, Tribal affili-
5 ation, or disability, in agency decisionmaking and
6 other Federal activities that affect human health
7 and the environment so that people—

8 (A) are fully protected from dispro-
9 portionate and adverse human health and environ-
10 mental effects (including risks) and hazards, in-
11 cluding those related to climate change, the cu-
12 mulative impacts of environmental and other
13 burdens, and the legacy of racism or other
14 structural or systemic barriers; and

15 (B) have equitable access to a healthy, sus-
16 tainable, and resilient environment in which to
17 live and engage in cultural and subsistence
18 practices.

19 (5) YOUTH ADVISORY COUNCIL.—The term
20 “Youth Advisory Council” means a Youth Advisory
21 Council established by a covered agency head pursu-
22 ant to section 3(a).

23 **SEC. 3. YOUTH ADVISORY COUNCILS.**

24 (a) ESTABLISHMENT.—Each covered agency head
25 shall establish within the respective agency of the covered

1 agency head a Youth Advisory Council for the purpose of
2 providing recommendations to the applicable covered
3 agency head with respect to governmental approaches to
4 environmental issues as those issues relate to youth, in-
5 cluding—

6 (1) recommendations with respect to programs
7 to help the governments of disadvantaged commu-
8 nities address environmental issues in those dis-
9 advantaged communities;

10 (2) recommendations with respect to perform-
11 ance measures that could be used to measure the
12 impact of climate change and other environmental
13 harms that affect youth communities; and

14 (3) researching, writing reports on, and making
15 recommendations with a focus on environmental jus-
16 tice, climate change mitigation and resiliency, and
17 pollution reduction.

18 (b) MEMBERSHIP.—

19 (1) SIZE.—A Youth Advisory Council shall con-
20 sist of not fewer than 15, and not greater than 25,
21 representative members of non-Federal interests
22 that have demonstrated high levels of knowledge and
23 expertise in environmental issues, to be appointed by
24 the applicable covered agency head.

25 (2) REQUIREMENTS.—

1 (A) AGE.—A member of a Youth Advisory
2 Council shall have an age, at the time of ap-
3 pointment or reappointment under paragraph
4 (4), of not less than 16 years and not more
5 than 29 years.

6 (B) GEOGRAPHIC DIVERSITY REQUIRED.—
7 A covered agency head shall seek to ensure that
8 members of a Youth Advisory Council are from
9 geographically diverse locations across the
10 United States.

11 (C) CONSIDERATION OF BACKGROUNDS.—

12 (i) IN GENERAL.—In selecting mem-
13 bers of a Youth Advisory Council, a cov-
14 ered agency head shall consider candidates
15 with varying backgrounds, including—

16 (I) business and industry;

17 (II) academic institutions;

18 (III) State, local, and Tribal gov-
19 ernments;

20 (IV) public interest groups;

21 (V) environmental organizations;

22 and

23 (VI) service groups.

24 (ii) REQUIREMENT.—Of the members
25 of a Youth Advisory Council, not more

1 than 60 percent may come from any 1 cat-
2 egory described in clause (i).

3 (D) REPRESENTATION OF DISADVANTAGED
4 COMMUNITIES.—Of the members of a Youth
5 Advisory Council, not less than 50 percent shall
6 come from, reside primarily in, or work pri-
7 marily in disadvantaged communities.

8 (E) DIVERSITY, EQUITY, INCLUSION, AND
9 ACCESSIBILITY CONSIDERATIONS.—In selecting
10 members of a Youth Advisory Council, a cov-
11 ered agency head shall consider diversity, eq-
12 uity, inclusion, and accessibility, in accordance
13 with Executive Order 14035 (42 U.S.C. 2000e
14 note; relating to diversity, equity, inclusion, and
15 accessibility in the Federal workforce).

16 (3) TERM.—A member of a Youth Advisory
17 Council shall serve for a term of 2 years.

18 (4) REAPPOINTMENT.—A covered agency head
19 may reappoint members of a Youth Advisory Council
20 to that Youth Advisory Council.

21 (5) VACANCIES.—A vacancy in a Youth Advi-
22 sory Council—

23 (A) shall not affect the powers of the
24 Youth Advisory Council; and

1 (B) shall be filled in the same manner as
2 the original appointment.

3 (6) DESIGNATED FEDERAL OFFICER.—Each
4 covered agency head shall appoint a full-time em-
5 ployee of the agency of the covered agency head to
6 serve as the designated Federal officer for the appli-
7 cable Youth Advisory Council.

8 (7) CO-CHAIRPERSONS; VICE-CHAIRPERSONS.—
9 Each covered agency head shall, from among the
10 members of the applicable Youth Advisory Council,
11 appoint 2 co-chairpersons and 2 vice-chairpersons.

12 (c) MEETINGS.—

13 (1) FREQUENCY.—A Youth Advisory Council
14 shall meet at the call of the applicable designated
15 Federal officer, but not less frequently than annu-
16 ally.

17 (2) OPEN MEETINGS.—The meetings of a
18 Youth Advisory Council shall be open to the public
19 unless the covered agency head determines, in ac-
20 cordance with section 552b(c) of title 5, United
21 States Code, to close a meeting or portion of a meet-
22 ing.

23 (3) AGENDA.—The agenda of a meeting of a
24 Youth Advisory Council shall be approved in advance
25 by the applicable designated Federal officer.

1 (4) REQUIREMENT.—A Youth Advisory Council
2 or subcommittee of a Youth Advisory Council may
3 not meet without the presence of the applicable des-
4 ignated Federal officer (or a designee).

5 (5) PUBLIC PARTICIPATION.—A person inter-
6 ested in the proceedings of a Youth Advisory Council
7 or interested in providing comment on a matter be-
8 fore a Youth Advisory Council may—

9 (A) attend meetings of the Youth Advisory
10 Council;

11 (B) appear before the Youth Advisory
12 Council; and

13 (C) file written comments with the Youth
14 Advisory Council.

15 (6) ADJOURNMENT.—The designated Federal
16 officer for a Youth Advisory Council may adjourn
17 the meeting of the Youth Advisory Council if the
18 designated Federal officer determines it is in the
19 public interest to do so.

20 (d) SUBCOMMITTEES.—A Youth Advisory Council
21 may establish subcommittees as determined appropriate
22 by the Youth Advisory Council.

23 (e) EDUCATION.—Each covered agency head shall de-
24 velop and provide to members of the Youth Advisory
25 Council an educational curriculum, which shall include

1 briefings on the organizational structure and work of the
2 agency of the covered agency head.

3 (f) **REPORTS.**—Not less frequently than annually, a
4 Youth Advisory Council shall submit to the applicable cov-
5 ered agency head a report describing any recommenda-
6 tions of the Youth Advisory Council made in accordance
7 with subsection (a).

8 (g) **ADMINISTRATIVE SUPPORT.**—The agency of a
9 covered agency head shall provide administrative support
10 to the Youth Advisory Council of the agency.

11 (h) **APPLICABILITY OF FACA.**—Section 1013 of title
12 5, United States Code, shall not apply to a Youth Advisory
13 Council.

14 (i) **APPLICABILITY TO EXISTING COUNCILS.**—The
15 Administrator of the Environmental Protection Agency
16 may, in accordance with this Act, designate the National
17 Environmental Youth Advisory Council as the Youth Advi-
18 sory Council of the Environmental Protection Agency.

19 **SEC. 4. AUTHORIZATION OF APPROPRIATIONS.**

20 There is authorized to be appropriated \$250,000 to
21 each of the Environmental Protection Agency, the Depart-
22 ment of the Interior, the Department of Energy, the De-
23 partment of Agriculture, and the Department of Com-

1 merce for each of fiscal years 2025 through 2035 for the
2 purpose of carrying out this Act.
